I. Executive Brief
Motion and Title: Staff recommends motion to approve: A Budget Transfer of \$1,420,000 in the Abacoa Impact Fee Account to recognize revenue received in FY 2007 and appropriate it to the Abacoa Impact Fee Account - Contributions to Other Governmental Agencies for payment to the Northern Palm Beach County Improvement District.
Summary: This Budget Transfer is necessary to appropriate revenue collected in FY 2007. This amendment allows the County to remit road impact fees to the Northern Palm Beach County Improvement District for the construction of Indian Creek Parkway East and the Donald Ross Road Project in accordance with an impact fee agreement between Palm Beach County, Abacoa Development Company and the Northern Palm Beach County Improvement District.
