I. EXECUTIVE BRIEF


Motion and Title: Staff recommends motion to approve: Budget transfer of \$250,000 in Park Improvement fund from New Project reserves to American Homes Park Improvements (\$200,000) and Agricultural Reserve District Park (\$50,000).

Summary: This transfer will provide necessary funding to complete park improvement projects currently underway at American Homes Park and Agricultural Reserve District Park (AKA Palm Beach Downs). Funding is from the Park Improvement Fund reserve. District 5 (AH)


Background and Justification: American Homes Park is a community park located on Liberty Road in Boca Raton. The northern portion of this park was recently sold, creating the opportunity for renovation of the property. The renovation project consists of the relocation of the playground, exotic removal, landscaping and other various park improvements.

Agricultural Reserve District Park is a 333-acre district park located near Atlantic Avenue and State Road 7 in Delray Beach. This property is currently leased from the South Florida Water Management District, and is being developed as a passive park, as well as to accommodate various user groups. Project elements include the removal of exotics and the creation of trails and picnic areas.
