## I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Supplement No. 1 to Consultant Services Authorization (CSA) No. 5 to contract with Stephen Boruff Architects + Planners, Inc. (R2006-0073) in the amount of \$161,600 for professional services related to replacement Fire Station No. 32 located on Lake Worth Road.

Summary: Stephen Boruff Architects + Planners, Inc. have completed a due diligence report that included preliminary site planning and survey work. This supplement authorizes the consultant to proceed with professional services for providing design, development of construction documents, bidding, and construction services for the proposed replacement Fire Station No.32. (Capital Improvements Division) District 2 (JM)

Background and Justification: The proposed replacement Fire Station No. 32 is part of Fire-Rescue's Capital Program to provide an improved level of services to the surrounding community. The replacement Fire Station will be a 2-story design and will be used as future prototype. The existing Fire Station will remain in operation until the replacement station is complete, and then the existing station will be demolished. The preliminary site planning and due diligence has proceeded to the extent that the next phase of completing the design and construction documents is required at this time. The professional services detailed within this supplement are consistent with the tasks associated with providing the documents for bidding and construction.




