

UNITY OF TITLE

In consideration of the issuance of a Development Permit to Palm Beach County, a political subdivision of the State of Florida, in Palm Beach County, Florida, for site development and for other good and valuable consideration, the undersigned hereby agrees to restrict the use of the property legally described in Exhibit "A", attached hereto and made a part hereof, in the following manner:

- 1. That said property shall be considered as one plot and parcel of land, and that no portion of said plot and parcel of land shall be sold, transferred, devised, or assigned separately except in its entirety as one plot or parcel of land.
- 2. The undersigned further agrees that this condition, restriction and limitation shall be deemed a covenant running with the land, and shall remain in full force and effect, and be binding upon the undersigned, their successors and assigns until such time as the same may be released in writing by the Village Manager of the Village of Wellington.
- 3. The undersigned further agrees that this instrument shall be recorded in the Public Records of Palm Beach County.
- 4. The conveyance of right-of-way required by government shall not be deemed to violate this Unity of Title.
