Water Utilities has requested an increase of \$99,750 over the previously authorized amount of \$199,500 to meet the County's requirements for additional odor control chemicals that are necessary due to the change in weather conditions. This is a sole-source provider who is not a certified SBE.

Community Services has requested \$500,000 for the 2007 Summer Food Program (06/04/07 through 8/17/07) due to a two (2) week extension in its summer camp program. This term contract has two (2) eleven (11) week renewal periods for the 2008 Summer Food Program and the 2009 Summer Food Program respectively. Because of Federal funding this project must adhere to the Federal DBE program rather than the County's SBE program.

Based upon the fixed unit price per service, \$350,617 is needed to meet the County's requirements through the expiration of this twelve (12) month renewal term contract. Water Utilities does not anticipate using the option for additional tasks at an hourly rate, as provided in the contract. This term contract has three (3) twelve (12) month renewal options.
