I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Amendment No. 2 to the annual Contract with Anna Cottrell & Associates, Inc. (R2004-1552) to provide for property development evaluation services on a continuing contract basis.

Summary: Anna Cottrell & Associates, Inc., was selected to provide professional consulting services for property development evaluations. The Board approved an annual contract on July 13, 2004 for an initial two (2) year term with two (2) - one (1) year renewal options. This amendment would provide for services during the second and final renewal period. Anna Cottrell & Associates has an SBE participation goal of 15%. During the first three years of the Contract, Anna Cottrell & Associates has achieved 91.6% participation. (Capital Improvements Division) Countywide(JM)

Background and Justification: In accordance with Board adopted procedures pursuant to Florida Statute 287.055 (Consultants Competitive Negotiation Act), Anna Cottrell & Associates was one of two firms selected to perform professional consulting services on a continuing contract basis. Work is authorized through individual task agreements when required during the term of this contract. The initial contract term is for two years and two additional one year renewals. This amendment would provide services during the second and final renewal period and would be the fourth year of the contract. It is the consensus of Facilities Development & Operations that Anna Cottrell & Associates has successfully provided the professional services required by the County in a timely manner. They are in good standing and wish to continue to provide professional services. This Amendment will maintain the continuous professional services required by the County. During the first three years of the Contract, Anna Cottrell & Associates was awarded \$178,382 in Consultant Service Authorizations.
