I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Amendment No. 2 to the annual Contract with Kilday & Associates, Inc. (R2004-1551) to provide for property development evaluation services on a continuing contract basis.

Summary: Kilday & Associates, Inc., was selected to provide professional consulting services for property development evaluations. The Board approved an annual contract on July 13, 2004 for an initial two (2) year term with two (2) - one (1) year renewal options. This amendment would provide for services during the second and final renewal period. Kilday & Associates has an SBE participation goal of 15%. During the first three years of the Contract, Kilday & Associates has achieved 24.8% participation. (Capital Improvements Division) Countywide(JM)

Background and Justification: In accordance with Board adopted procedures pursuant to Florida Statute 287.055 (Consultants Competitive Negotiation Act), Kilday & Associates was one of two firms selected to perform professional consulting services on a continuing contract basis. Work is authorized through individual task agreements when required during the term of this contract. The initial contract term is for two years and two additional one year renewals. This amendment would provide services during the second and final renewal period and would be the fourth year of the contract. It is the consensus of Facilities Development & Operations that Kilday & Associates has successfully provided the professional services required by the County in a timely manner. They are in good standing and wish to continue to provide professional services. This Amendment will maintain the continuous professional services required by the County. During the first three years of the Contract, Kilday & Associates was awarded \$539,970 in Consultant Service Authorizations.

Annual Property Development Evaluation Services
Continuing Contract Basis

This Amendment #2 dated _____, to the Agreement (R-2004-1551) dated July 13 2004, by and between Palm Beach County, a political subdivision of the State of Florida, by and through its Board of Commissioners, hereinafter referred to as the COUNTY and Kilday & Associates, Inc., a corporation authorized to do business in the State of Florida, hereinafter referred to as the CONSULTANT.

WITNESSETH

WHEREAS, the parties have entered into an Agreement under which the CONSULTANT provided certain professional services to the COUNTY for various projects in accordance with Consultants Competitive Negotiations Act (CCNA) FS 287.055; and

WHEREAS, the parties hereto desire to amend the Agreement to extend it for an additional one (1) year period.

NOW, THEREFORE, in consideration of the premises and of the mutual covenants hereinafter set forth and for such other good and valuable consideration, the receipt of which the parties hereto expressly acknowledge, the parties covenant and agree to the following terms and conditions:

1. The term of this Agreement as set forth in Section 4, Article 4.1 is renewed for one (1) additional year to July 13, 2008.
2. Except as specifically modified above, the terms and conditions of the Agreement are hereby confirmed and remain in full force and effect.






