I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: A contract with M.A.C. Construction, Inc. for the Job Order Contract-Central with a maximum value of \$2,500,000.00.

Summary: This contract is for one (1) year and is an indefinite-quantity, fixed unit price contract that has a minimum value of \$35,000 and a maximum value of \$2,500,000. The contract will terminate when a total of \$2,500,000 in work orders is issued or when the one-year time period has expired, whichever comes first. The contract provides for two (2) - one (1) year renewals at the sole option of the County. M.A.C. Construction, Inc. will perform work identified by the County on a work order basis, in accordance with the cost factor adjustments to the Unit Price Books.SBE goals established for this contract are 15%. (FDO Admin) Countywide (JM)

Background and Justification: Bids were opened on April 24, 2007 for JOC-Central with M.A.C. Construction, Inc. submitting the second lowest responsive, responsible bid. The contract is effective for a period of twelve months or at the point where the maximum potential contract amount of \$2,500,000 is reached. Two (2) Central contracts will be established through this solicitation due to the projected work load, which will bring the County to its full complement of seven (7) JOC contractors.

SBE participation goals for JOC were established at 15%. SBE utilization is monitored on a project basis, with consideration given to availability, relative to the project scope. M.A.C. Construction, Inc. is not a certified SBE vendor.
