Motion and Title: Staff recommends motion to approve:

A) a Budget Transfer in the amount of \$3,269,338 to increase funding for the HOME Countywide First-Time Homebuyer Program; and

B) the utilization of recaptured funds in the amount of \$3,221,241 and interest income in the amount of \$48,097 from Fiscal Years 2004-2005, 2005-2006 and 2006-2007, to provide financial assistance to eligible first-time home buyers.

SUMMARY: This Budget Transfer will allow recaptured funds and interest income to be utilized and transferred into the HOME Countywide First-Time Homebuyer Program, thereby increasing the countywide current budget from \$1,371,084 to \$4,640,422. These recaptured funds were derived from first-time home buyers who repaid the financial assistance received from the First-Time Homebuyer Program activity for Fiscal Years 2004-2005, 2005-2006 and 2006-2007. These funds will be utilized to provide financial assistance to lower income firsttime home buyer households. Countywide (TKF)

Background and Justification: Palm Beach County Housing and Community Development (HCD) receives HOME Investment Partnership Program (HOME) funds from the U.S. Department of Housing and Urban Development (HUD) to implement eligible housing activities. HOME funds afford state and local governments the flexibility to fund a wide range of housing activities through creative and unique housing partnerships among nonprofit organizations, and private industry that benefit low and very-low persons. In accordance with the HOME Investment Partnerships Program Final Rule 92.254 (a)(5)(ii)(A)(5), recaptured funds must be used to carry out HOME eligible activities.
