

DECLARATION OF MAINTENANCE COVENANTS

Perpetual maintenance includes, but is not limited to, maintenance of pavers, irrigation system, pruning, fertilizing, and alternative watering of Xeriscape landscaping material during periods of drought in order to maintain healthy plant material.
