I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: A Budget Transfer of \$20,000 in the Transportation Improvement Fund from Reserve for District 5 to Sun Valley Curbing – District 5.

Summary: The District 5 Transportation Improvement Fund will pay for the requested curbing on El Clair Ranch Road to improve safety and reduce u-turns in the swales.


