I. EXECUTIVE BRIEF

Motion and Title: Staff recommends a motion to approve: A) Expenditure in the amount of \$732,422 from the Capital Outlay Fund to increase funding for the Royal Palm Estates Paving and Drainage project; and B) A Budget Transfer of \$732,422 in the Capital Outlay Fund from CCRT Recoup Funding to the Royal Palm Estates Paving and Drainage project.

Summary: The Royal Palm Estates Paving and Drainage project was originally reviewed and recommended for funding by the Countywide Community Revitalization Team (CCRT) Committee in February 2002 and approved by the Board of County Commissioners (BCC) on March 26, 2002. The additional \$732,422 is needed to complete this long-term project. <u>District 6</u> (AH)

Background and Justification: The BCC has allocated a total of \$1,017,578 to this project. Funding was provided in fiscal years 2002-2003, 2003-2004, 2004-2005, and 2005-2006. In response to numerous residents' requests, the Office of Community Revitalization (OCR) met with the residents of Royal Palm Estates. Based on community meetings with the residents and County Engineering, it was determined that the paving and drainage project should be completed as soon as funds became available. The requested funds are available from the CCRT Recoup Fund and will be used to complete the project.
