I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Supplemental Agreement No. 9 to Project Agreement R2001-1619 in the amount of \$135,630 with K-F Group, Inc. (KFG), for professional services.

Summary: This Supplemental Agreement will provide the services necessary for the preparation of plan revisions and acquisition of a Tree Alteration Permit for Jog Road from Roebuck Road to 45th Street (Project).

Districts: 2 and 6 (PK)

Background and Justification: On October 2, 2001, the Board of County Commissioners (Board) approved an Agreement (R2001-1619) with KFG to provide professional services required to prepare design plans and construction bid documents for the Project. The County now desires KFG to provide additional services for the design of a new bridge and to obtain a Tree Alteration Permit from the City of West Palm Beach for the Project, as detailed in Exhibit "A" of the attached Supplemental Agreement. The Small Business Enterprise (SBE) goal for the Project is 15%. The SBE participation committed for this supplement by KFG is 94.11% overall. The fee, as detailed in Exhibit "A" of the attached Supplemental Agreement, has been negotiated as just and reasonable compensation as follows:



Gentlemen:

INTRODUCTION

Following discussions with Mr. Alan Gerwig, P.E. of Gerwig & Associates, Inc. and a visit to the site, Dunkelberger Engineering & Testing, Inc. (DE&T) is pleased to submit this proposal to perform a subsurface study in connection with the Jog Road vehicular bridge that is to be built over the NPB Canal in Palm Beach County, Florida. Presented hereafter are a description of the scope of work that we will undertake for the project and a schedule for implementation of the work. Compensation for our services is also discussed.

PROJECT CONSIDERATIONS

Based upon discussions with Mr. Gerwig, we understand that the bridge will be a single span structure with an overall width of $100\pm$ feet and four travel lanes. It will be constructed of precast, reinforced concrete components and have a poured-in-place concrete deck. The bridge superstructure will be supported on driven precast, prestressed concrete (PPC) piles. Per pile service loads are estimated to be on the order of 70 to 80 tons.

SCOPE OF WORK

Subsurface conditions at the bridge location will be explored with two 75-foot deep engineering borings (one at each abutment location). The borings will be accomplished with truck-mounted machinery using mud rotary procedures. Samples of the in-place materials will be obtained at frequent vertical intervals using a standard split barrel driven with a 140-pound drop hammer freely falling 30 inches (the Standard Penetration Test [SPT] after ASTM D 1586). Upon their completion, the borings will be grout sealed from bottom to top.

The axial compressive capacity that the piling can develop within the profile components will be estimated using the Florida Department of Transportation (FDOT) computer program SPT 97. Axial compressive capacities will be estimated for both 14-inch square and 18-inch square PPC piles. Output from the computer program will be presented graphically as curves of driven pile capacity versus depth.

A sample of the subsurface materials will be tested for the Florida Department of Transportation corrosion parameters.

The work product of our efforts will be a brief but comprehensive report which transmits the factual information obtained, the estimated capacity versus embedment curves for the piling and our recommendations for foundation design and related construction.

Also included within this scope of work is DE&T's continued consultations for the Jog Road -45^{th} Street intersection improvements, a project that includes the design of a retaining wall and thick fill over an existing lake. We will attend meetings and provide geotechnical engineering consultations to the design team on an hourly rate basis.

<u>SCHEDULE</u>

We are in a position to begin the field exploration within about five business days of receiving your notification to proceed. Barring delays due to inclement weather, we expect to complete the drilling and sampling of the borings in two days. The report of the subsurface study will be submitted to you about one week after the field exploration is concluded.

COMPENSATION, PAYMENT AND OTHER TERMS

Based upon our general knowledge of the subsurface conditions of the site area and an interpretation of your requirements, we are willing to provide the services described earlier for a fixed fee of \$7,970. A breakdown of the fee is given in Attachment 1.

Invoices for our services are due and payable upon receipt. Invoices not paid within 30 days of their date will be assessed a finance charge of one percent per month, or fraction thereof, for each month beyond 30 days past due. Invoices not paid within 60 days will result in DE&T stopping work until such invoices are paid in full. Invoices not paid within 90 days of their date will be referred for collection. The client will be responsible for all expenses incurred by DE&T in the collection of any unpaid invoice, including the actual attorneys' fees and costs charged by our legal counsel.
