I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to receive and file: original executed Amendment to Request for Funding Form for a School Board Recreation Assistance Program project for Boynton Beach Community High School's participation in the Washington, D.C. Presidential Classroom Project (R2007-0999) to extend the project completion date from June 30, 2007, to September 30, 2007, and to increase the project funding amount from \$3,000 to \$4,300 to include an additional \$1,300 allocation from District 7.

Summary: This fully executed Amendment to Request for Funding Form is being processed in accordance with the Interlocal Agreement for the Funding of Recreation Assistance Program (RAP) Projects (R2003-1747) approved by the Board on October 21, 2003. The additional funding is from the Recreation Assistance Program (RAP) District 7 Funds. District 3 (AH)

Background and Justification: The Interlocal Agreement for the Funding of RAP Projects (R2003-1747) was adopted by the Board to streamline the RAP process. It establishes terms and conditions for all School Board RAP capital and operational projects up to a set amount of \$100,000 and approves the use of the Request for Funding Form for School Board Capital and Operational Projects forms to provide necessary project information for establishing eligibility of projects and setting forth project descriptions, time frames, and budgets. The Agreement also delegates signature of these Forms and Amendments to designated School District and County staff. Fully executed originals of the Request for Funding Forms and Amendments are presented to the Board as Receive and File agenda items to keep the Board apprised of all approved County RAP allocations to the School Board, and to provide for proper recording and budgeting of the Request for Funding Forms and Amendments.






