#### I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: the Notice of Cancellation of Lease Agreement (R2005-1714) with Habitat for Humanity Palm Beach County, Inc.

Summary: On September 15, 2005, the Board approved a tri-party Lease Agreement with Habitat for Humanity Palm Beach County, Inc. and Truth, Responsibility, Unity, Training, Hope & Success, Inc. (TRUTH) for .33 acres of land located at 1031 and 1033 State Street, West Palm Beach for the operation of its 4-H Youth Community Garden Program. The term of the Lease Agreement will expire on March 21, 2008. TRUTH was dissolved in September 16, 2005, and has not participated in the community garden since that date. Due to the loss of funding through the 4-H Youth Community Garden Program, the Cooperative Extension Services Department has requested the cancellation of the Lease Agreement, which had an annual rental rate of \$1. The County has the right to cancel this Lease Agreement for any reason upon sixty (60) days prior written notice. (PREM) District 7 (HJF)

Background and Justification: The original Lease Agreement was approved on September 13, 2005, for an initial term of one (1) year. The term of the Lease Agreement has been automatically renewed for successive one (1) year periods with the current term expiring on March 21, 2008.


