AMENDMENT #2 TO CONTRACT FOR CONSULTING/PROFESSIONAL SERVICES

This agreement amends the contract between Palm Beach County (County) and The Gordian Group, Inc., (Consultant) authorized pursuant to Palm Beach County Resolution (R-2005-1489).

The original contract provided that Contractor would provide professional consultant services for the continuation of the Job Order Contracting (JOC) system from August 16, 2005 to August 15, 2007 or until the amount of fees paid total \$175,000, whichever occurred first. That contract also provides that it could be extended for two additional one-year terms, for a maximum of \$90,000 each. The contract was previously amended on December 5, 2006. This amendment exercises the second and final option to the contract, increasing the overall limit to \$355,000.

The County is extending the contract for a period of twelve (12) months based on pending work which would exceed the value assigned to the contract. Pursuant to the provisions of the existing contract, the parties agree that Consultant will continue to provide professional consulting services until September 10, 2008, or until the amount of fees paid total \$355,000, whichever occurs first.

Except as amended herein, all provisions of the existing contract shall remain in full force and effect.
