### I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Agreement with Delray Beach Playhouse, Inc. for the period September 11, 2007, through December 30, 2007, in an amount not-to-exceed \$10,000 for funding of a children's musical production.

**Summary:** This funding is to offset the cost of a children's musical production at Delray Beach Playhouse, which took place on July 20 and July 22, 2007. Approximately 100 participants took part in the production, which was viewed by an audience of approximately 2,000 people. The Agreement allows for the reimbursement of eligible project costs incurred subsequent to May 1, 2007. Funding is from the Recreation Assistance Program (RAP) District 4 Funds. <u>District 4 (AH)</u>

Background and Justification: Delray Beach Playhouse, Inc. is a not-for-profit organization that provides theatrical training to children in the area of acting, dance, singing, and technical support. Delray Beach Playhouse sponsored the production of a children's musical production, "The Cookie Crumbs". The production offered opportunities for local children to participate in producing and performing the play, and was viewed by the local community.

The total cost of the production was approximately \$20,000 for costumes, royalties, props, stage construction, and other miscellaneous expenses related to the production of the children's musical. The \$10,000 from RAP – District 4 will help offset half of the costs paid by Delray Beach Playhouse, Inc. The Agreement has been executed on behalf of Delray Beach Playhouse, Inc., and now needs to be approved by the Board of County Commissioners.

# AGREEMENT BETWEEN PALM BEACH COUNTY AND DELRAY BEACH PLAYHOUSE, INC. FOR FUNDING OF A CHILDREN'S MUSICAL PRODUCTION

THIS AGREEMENT is made and entered into on \_\_\_\_\_\_, by and between Palm Beach County, a political subdivision of the State of Florida, hereinafter referred to as "County", and Delray Beach Playhouse, Inc., a Florida not-for-profit corporation authorized to do business in the State of Florida, hereinafter referred to as "Delray Beach Playhouse".

#### WITNESSETH:

WHEREAS, Delray Beach Playhouse is a not-for-profit organization that provides theatrical training to children in the area of acting, dance, singing, and technical support; and

WHEREAS, Delray Beach Playhouse plans to sponsor the production of a children's musical production in the summer of 2007; and

WHEREAS, the production is estimated to cost approximately \$20,000 for costumes, royalties, props, stage construction, and other miscellaneous expenses related to the production; and

WHEREAS, Delray Beach Playhouse has requested \$10,000 from County to offset costs of the production; and

WHEREAS, County desires to provide funding to assist Delray Beach Playhouse with costs for the production program; and

WHEREAS, funding to assist Delray Beach Playhouse with production costs in an amount not-to-exceed \$10,000 is available from the Recreation Assistance Program (RAP) - District 4; and

WHEREAS, cultural programs for youth serve a public purpose; and WHEREAS, both parties desire to enter into this Agreement.

**NOW THEREFORE**, in consideration of the covenants and promises contained herein, the parties hereby agree to the following terms and conditions:

- 1. County agrees to fund an amount not-to-exceed \$10,000 to Delray Beach Playhouse for the production of a children's musical production during the summer of 2007 to include costumes, royalties, props, stage construction, and other miscellaneous expenses related to the production, as set forth in Exhibit "A", attached hereto and incorporated herein, hereinafter referred to as the "Project".
  - 2. County will use its best efforts to provide said funds to Delray Beach Playhouse

on a reimbursement basis within forty-five (45) days of receipt of the following information:

- a. A written statement that the Project, as specified herein, was carried out in accordance with this Agreement; and
- b. A Contract Payment Request Form and a Contractual Services Purchases Schedule Form attached hereto and made a part hereof as Exhibit "B", which are required for each and every reimbursement requested by Delray Beach Playhouse. Said information shall list each invoice paid by Delray Beach Playhouse and shall include the vendor invoice number; invoice date; and the amount paid by Delray Beach Playhouse along with the number and date of the respective check and/or proof of payment for said payment. Delray Beach Playhouse shall attach a copy of each vendor invoice paid by Delray Beach Playhouse along with a copy of the respective check and/or proof of payment, and shall make reference thereof to the applicable item listed on the Contractual Services Purchases Schedule. Further, Delray Beach Playhouse's Program Administrator and Project Financial Officer shall certify the total funds spent by Delray Beach Playhouse on the Project and shall also certify that each vendor invoice, as listed on the Contractual Services Purchases Schedule was paid by Delray Beach Playhouse and approved by Delray Beach Playhouse as indicated.
- 3. Delray Beach Playhouse incurred expenses for the Project beginning on May 1, 2007. Those costs incurred by Delray Beach Playhouse for the Project, approved and submitted accordingly by Delray Beach Playhouse subsequent to May 1, 2007, are eligible for reimbursement by County pursuant to the terms and conditions hereof.
- 4. RAP funds may be used as a match for other local, state, or federal grant programs, but Delray Beach Playhouse may not submit reimbursement requests for the same expenses to the County as other fund sources to receive duplicate reimbursement for the same expenses.
- 5. Delray Beach Playhouse warrants that it is an active not-for-profit corporation, duly chartered and registered with the Florida Department of State, Division of Corporations.
- 6. Delray Beach Playhouse agrees, warrants, and represents that all of the employees and participants in the Project will be treated equally during employment, and for the provision of services without regard to residency, race, color, religion, disability, sex, age, national origin, ancestry, marital status, or sexual orientation.

- 7. Delray Beach Playhouse shall be responsible for the operation and maintenance of the Project, including all associated costs.
- 8. The term of this Agreement shall be until December 30, 2007, commencing upon the date of execution by the parties hereto.
- 9. The parties agree that, in the event Delray Beach Playhouse is in default of its obligations under this Agreement, the County shall provide Delray Beach Playhouse thirty (30) days written notice to cure the default. In the event Delray Beach Playhouse fails to cure the default within the thirty (30) day cure period, the County shall have no further obligation to honor reimbursement requests submitted by Delray Beach Playhouse for the Project deemed to be in default and Delray Beach Playhouse shall return any County RAP funds already collected by Delray Beach Playhouse for that Project.
- 10. Notwithstanding any provision of this Agreement to the contrary, this Agreement may be terminated by the County, without cause, upon thirty (30) days prior written notice to the other party. This Agreement may be terminated by the County with cause, upon expiration of the thirty (30) day cure period provided for in Section 8 above.
- 11. Delray Beach Playhouse shall complete the Project by September 30, 2007, and invoices and checks submitted for reimbursement must be dated within the project time frame of May 1, 2007, through September 30, 2007. Delray Beach Playhouse shall provide its final reimbursement request(s), including a project completion statement and reimbursement documentation as indicated in Section 2 above on or before December 30, 2007. Upon written notification to County at least ninety (90) days prior to that date Delray Beach Playhouse may request an extension beyond this period for the purpose of completing the Project. County shall not unreasonably deny Delray Beach Playhouse's request for said extension.
- 12. In the event Delray Beach Playhouse ceases to exist, or ceases or suspends the Project for any reason, any remaining unpaid portion of this Agreement shall be retained by County, and County shall have no further obligation to honor reimbursement requests submitted by Delray Beach Playhouse. The determination that Delray Beach Playhouse has ceased or suspended the Project shall be made by County and Delray Beach Playhouse agrees to be bound by County's determination.
  - 13. Delray Beach Playhouse agrees to abide by, and be governed by, all applicable

federal, state, county, and municipal laws, including but not limited to, Palm Beach County's ordinances, as said laws and ordinances exist and are amended from time to time. In entering into this Agreement, Palm Beach County does not waive the requirements of any County or local ordinance or the requirements of obtaining any permits or licenses normally required to conduct business or activity conducted by Delray Beach Playhouse. Failure to comply may result in County's refusal to honor reimbursement requests for the Project.

- 14. County reserves the right to withhold reimbursement if the Project is not completed as specified in Exhibit "A".
- 15. It is understood and agreed that Delray Beach Playhouse is merely a recipient of County funding and is an independent contractor and is not an agent, servant or employee of County or its Board of County Commissioners. It is further acknowledged that the County only contributes funding under this Agreement and operates no control over the Project. In the event a claim or lawsuit is brought against County or any of its officers, agents or employees, Delray Beach Playhouse shall indemnify, save and hold harmless and defend the County, its officers, agents, and/or employees from and against any and all claims, liabilities, losses, judgments, and/or causes of action of any type arising out of or relating to any act or omission of Delray Beach Playhouse, its agents, servants and/or employees in the performance of this Agreement. The foregoing indemnification shall survive termination of this Agreement.
- 16. Delray Beach Playhouse shall, at its sole expense, agree to maintain in full force and effect at all times during the life of this Agreement, insurance coverages and limits (including endorsements), as described herein. The requirements contained herein, as well as County's review of acceptance of insurance maintained by Delray Beach Playhouse are not intended to and shall not in any manner limit or qualify the liabilities and obligations assumed by Delray Beach Playhouse under the Agreement.

Commercial General Liability. Delray Beach Playhouse shall maintain Commercial General Liability at a limit of liability not less than \$500,000 Each Occurrence. Coverage shall not contain any endorsement excluding Contractual Liability or Cross Liability unless granted in writing by County's Risk Management Department. Delray Beach Playhouse shall provide this coverage on a primary basis.

Worker's Compensation Insurance & Employer's Liability. Delray Beach

Playhouse shall maintain Worker's Compensation & Employers Liability in accordance with Florida Statute Chapter 440. Delray Beach Playhouse shall provide this coverage on a primary basis.

Additional Insured. Delray Beach Playhouse shall endorse the County as an Additional Insured with a CG 2026 Additional Insured - Designated Person or Organization endorsement, or its equivalent, to the Commercial General Liability. The Additional Insured endorsement shall read "Palm Beach County Board of County Commissioners, a Political Subdivision of the State of Florida, its Officers, Employees and Agents." Delray Beach Playhouse shall provide the Additional Insured endorsements coverage on a primary basis.

Waiver of Subrogation. Delray Beach Playhouse hereby waives any and all rights of Subrogation against the County, its officers, employees and agents for each required policy. When required by the insurer, or should a policy condition not permit an insured to enter into a pre-loss agreement to waive subrogation without an endorsement, then Delray Beach Playhouse shall agree to notify the insurer and request the policy be endorsed with a Waiver of Transfer of Rights of Recovery Against Others, or its equivalent. This Waiver of Subrogation requirement shall not apply to any policy, when a condition to the policy specifically prohibits such an endorsement, or voids coverage should Delray Beach Playhouse enter into such an agreement on a pre-loss basis.

Certificate(s) of Insurance. Prior to execution of this Agreement by the County, Delray Beach Playhouse shall deliver to the County a Certificate(s) of coverage evidencing that all types and amounts of insurance coverages required by this Agreement have been obtained and are in full force and effect. Such Certificate(s) of Insurance shall include a minimum thirty (30) day endeavor to notify due to cancellation or non-renewal of coverage. Certificate holder's address shall read Palm Beach County, c/o Parks and Recreation Department, 2700 Sixth Avenue South, Lake Worth, FL 33461, Attention: Administrative Support Manager.

Right to Review. County, by and through its Risk Management Department, in cooperation with the contracting/monitoring department, reserves the right to review, modify, reject or accept any required policies of insurance, including limits, coverages, or endorsements, herein from time to time throughout the term of this Agreement. County reserves the right, but not the obligation, to review and reject any insurer providing

coverage because of its poor financial condition or failure to operate legally.

17. Upon request by County, Delray Beach Playhouse shall demonstrate financial accountability through the submission of acceptable financial audits performed by an independent auditor.

18. Delray Beach Playhouse shall maintain books, records, documents and other evidence that sufficiently and properly reflect all costs of any nature expended in the performance of this Agreement for a period of not less than five (5) years. Upon advance notice to Delray Beach Playhouse, County shall have the right to inspect and audit said books, records, documents and other evidence during normal business hours.

19. The County and Delray Beach Playhouse may pursue any and all actions available under law to enforce this Agreement including, but not limited to, actions arising from the breach of any provision set forth herein.

20. This Agreement shall be governed by the laws of the State of Florida and any and all legal action necessary to enforce this Agreement shall be held in Palm Beach County.

21. As provided in Section 287.132-133, Florida Statutes, by entering into this Agreement or performing any work in furtherance hereof, Delray Beach Playhouse certifies that it, its affiliates, suppliers, subcontractors and consultants who will perform hereunder, have not been placed on the convicted vendor list maintained by the State of Florida Department of Management Services within the thirty six (36) months immediately preceding the date hereof. This notice is required by Section 287.133 (3) (a), Florida Statutes.

22. This Agreement represents the entire agreement between the parties and supersedes all other negotiations, representations, or agreement, either written or oral, relating to this Agreement. This Agreement may be modified and amended only by written instrument executed by the parties hereto.

23. Any notice given pursuant to the terms of this Agreement shall be in writing and hand delivered or sent by U.S. mail. All notices shall be addressed to the following:
