I. EXECUTIVE BRIEF
Motion and Title: Staff recommends motion to adopt a Resolution: a) conceptually approving a grant in the amount of \$86.9 million to the Max Planck Society for the purposes of seeking matching funds from the State of Florida; b) authorizing the Business Development Board to facilitate the application for matching funding from the State of Florida Innovation Incentive Fund; c) authorizing staff to commence negotiations with the Max Planck Society to establish the terms and conditions of the Grant Agreement; d) authorizing staff to commence negotiations with Florida Atlantic University and Scripps Florida for temporary facilities for the Max Planck Society; and e) authorizing staff to commence negotiations with Florida Atlantic University for six (6) acres of land upon which the Max Planck Florida Institute will be located.
Summary: The Max Planck Society requires funding in the amount of \$181.8 million to construct and operate a 100,000 square feet Bioscience Institute, Max Planck Florida Institute on the Campus of Florida Atlantic University in Jupiter. Of this amount, \$86.9 million is anticipated to be funded by Palm Beach County and \$94.9 million is anticipated to be funded by the State of Florida. The State's portion is contingent upon receiving approval by the Governor and Legislature under the Innovation Incentive Fund. The State of Florida has appropriated \$250 million in an Innovative Incentive Fund for this fiscal year. The research institutes of Max Planck employ approximately 23,400 people worldwide, and performs basic research in the interest of the general public in the natural sciences, life sciences, social sciences and the humanities. Since 1990, the organization has successfully spun-off 76 companies. The organization also has produced 16 Nobel Prize winners since 1948. Countywide (JM)

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA; CONCEPTUALLY APPROVING A GRANT IN THE AMOUNT OF \$86.93 MILLION TO THE MAX PLANCK SOCIETY FOR THE PURPOSES OF SEEKING MATCHING FUNDING FROM THE STATE OF FLORIDA; AUTHORIZING THE BUSINESS DEVELOPMENT BOARD TO FACILITATE THE APPLICATION FOR MATCHING FUNDING FROM THE STATE OF FLORIDA INNOVATION INCENTIVE FUND; AUTHORIZING STAFF TO COMMENCE NEGOTIATIONS WITH THE MAX PLANCK SOCIETY TO ESTABLISH THE TERMS AND CONDITIONS OF THE GRANT AGREEMENT: AUTHORIZING STAFF TO COMMENCE NEGOTIATIONS WITH FLORIDA ATLANTIC UNIVERSITY AND SCRIPPS FLORIDA FOR TEMPORARY FACILITIES FOR THE MAX PLANCK SOCIETY; AND AUTHORIZING STAFF TO NEGOTIATE WITH FLORIDA ATLANTIC UNIVERSITY FOR SIX ACRES OF LAND UPON WHICH THE MAX PLANCK FLORIDA INSTITUTE WILL BE LOCATED.

WHEREAS, Palm Beach County and the State of Florida have undertaken a visionary initiative to transform the economic landscape of the State and the County by investing in a Life Science Cluster; and

WHEREAS, Palm Beach County made a significant financial investment in a Life Science Cluster through a grant to the Scripps Research Institute for the construction of their permanent facilities in Palm Beach County; and

WHEREAS, the Board of County Commissioners desires to grow the Life Science cluster in Palm Beach County by providing an incentive to the Max Planck Society; and

WHEREAS, on March 13, 2007 the Board of County Commissioners adopted a Strategic Economic Development Plan which seeks to grow the County's economic base by promoting the County internationally; and

WHEREAS, the Max Planck Society is comprised of 78 institutes, research centers, laboratories and project groups worldwide; and

WHEREAS, the Max Planck Society has created 76 spin-off companies since 1990; and

WHEREAS, the Max Planck Society employs approximately 23,400 people worldwide; and

WHEREAS, the Max Planck Society has had 16 Nobel laureates since 1948, and

WHEREAS, the Max Planck Society desires to create its first institute within North America, Max Planck Florida Institute, in Palm Beach County; and

WHEREAS, the Max Planck Society desires to locate their Florida Institute on Florida Atlantic University's Jupiter Campus; and

WHEREAS, International Max Planck Research Schools will be used as a basis for establishing a new educational framework for Ph.D. candidates in Florida; and

WHEREAS, the Max Planck Society's scientific involvement in Florida will serve to boost the educational and training opportunities available to students, both K-12 and college level, and junior scientists; and

WHEREAS, the Max Planck Society and Scripps Florida have agreed on synergistic research profiles aimed at improving education and healthcare within Palm Beach County and the State of Florida thus creating an opportunity to accelerate the development of a Life Science Cluster; and

WHEREAS, the Innovation Incentive Program was created within the Office of Tourism, Trade, and Economic Development to ensure that sufficient resources are available to allow the State to respond expeditiously to extraordinary economic development and innovation business projects; and

WHEREAS, the Legislature of the State of Florida has appropriated \$250 million to fund the Innovation Incentive Program.

# NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, THAT:

- 1. The foregoing recitals are true and correct and are incorporated herein.
- 2. The Board of County Commissioners hereby: (i) conceptually approves a grant in the amount of \$86.93 million to the Max Planck Society for the purposes of seeking matching funding from the State of Florida; (ii) authorizes the Business Development Board to facilitate application for matching funds from the State of Florida Innovation Incentive Fund; (iii) authorizes staff to commence negotiations with the Max Planck Society to establish the terms and conditions of the Grant Agreement (iv) authorizes staff to commence negotiations with Florida Atlantic University and Scripps Florida for temporary facilities for the Max Planck Society; (v) authorizes staff to negotiate with Florida Atlantic University for six acres of land upon which the Max Planck Florida Institute will be located.
- 3. It is understood, that no contractual relationship is created by this Resolution and should the State of Florida not approve matching funds or the County and the Max Planck fail to successfully negotiate a Grant Agreement outlining the Terms and Conditions of the grant then this Resolution shall be repealed.
- 4. If any section, sentence, clause, phrase, or word of this Resolution is held invalid or unconstitutional by a Court of competent jurisdiction, then said holding shall in no way affect the validity of the remaining portions of this Resolution.
  - 5. This Resolution shall become effective immediately upon adoption.
