# I. EXECUTIVE BRIEF

# Title: Nonpartisan Elections for the following County Officials: Board of County Commissioners,

**Summary:** On September 11, 2007, the Board directed staff to present information concerning the possibility of requiring nonpartisan elections for the Offices of the Palm Beach County Board of County Commissioners,

On July 23, 2002, the BCC approved three ordinances (2002-31, 2002-32, 2002-33) that submitted to referendum three amendments to the County Charter that upon approval of Palm Beach County electors would provide for nonpartisan elections for the Property Appraiser, Sheriff and the Supervisor of Elections. These referendums were approved with an effective date of January 1, 2003.

The County Attorney's Office has provided proposed language for the Board's consideration including January 29, 2008, and November 4, 2008, as possible County-wide election dates for referendums to be placed on the ballot. Requirements for the January 29, 2008, election date would include an October 2, 2007, preliminary reading and advertisement for public hearing on October 16, 2007, and ballot language submittal to the Supervisor of Elections Office by November 16, 2007. #### **CHARTER AMENDMENT (County Commission)**

#### Sec. 2.2(a) Nonpartisan Elections

Elections for the members of the Board of County Commissioners shall be on a nonpartisan basis. No candidate shall be required to pay any party assessment or be required to state the party of which the candidate is a member. All candidates' names shall be placed on the ballot without reference to political party affiliation. In the event more than two candidates have qualified for any single commission office, an election shall be held at the time of the first primary election and, providing no candidate receives a majority of the votes cast, the two candidates receiving the most votes shall be placed on the ballot for the general election.

# REQUIRING NONPARTISAN ELECTIONS FOR THE BOARD OF COUNTY COMMISSIONERS

Shall the Charter of Palm Beach County be amended to require nonpartisan elections for the Board of County Commissioners, and to require a primary election when more than two such candidates qualify for election for the same commission office, and a runoff election when no candidate for the same commission office receives a majority of the votes in the primary election?
