I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: A Time Extension for a Joint Participation Agreement (JPA) with the Florida Department of Transportation (FDOT) concerning the preparation of an Interchange Justification Report (IJR) for Central Boulevard and I-95 (Project).

Summary: This Time Extension will extend the expiration of the JPA to September 30, 2008.

Background and Policy Issues: On December 17, 2002, the Board of County Commissioners (Board) approved a JPA (R2002-2231) with FDOT concerning the preparation of an LJR for the Project. The JPA provided for FDOT's participation in funding up to one-half of the cost of the LJR, not to exceed \$175,000. The JPA expires on September 30, 2007.


