



Cancellation of Memorandum Agreement dated October 5,

1976 (R-76-917) for a water plant and wells at PBIA

On October 5, 1976, (R-76-917), the Board of County Commissioners approved the above referenced Memorandum Agreement between the Department of Airports and the Water Utilities Department. This Memorandum Agreement was amended on June 24, 1986 (R-86-924), April 24, 1990 (R-90-665) and June 6, 1995 (R-95-754), the latter revising the term to automatic October 1st to September 30th renewals unless canceled by either party with thirty days advance written notice.

In a March 23, 2007, Memorandum from WUD to this office (copy attached), WUD requested the Memorandum Agreement be terminated as the water plant was demolished and the property no longer needed. In a June 5, 2007, Memorandum from Airports to this office (copy attached), Airports concurred with WUD and determined that the leased property was in an acceptable condition to be returned.

As proper cancellation notice was provided by WUD, and approval of same was subsequently granted by Airports, this office will present a "receive and file" motion at the Board's October 2, 2007, agenda, to record the cancellation of the Memorandum Agreement effective September 30, 2007.
