I. Executive Brief

Motion and Title: STAFF RECOMMENDS MOTION TO APPROVE: the creation of one (1) full time position to administer contracts and oversee administrative functions for the convention center.

Summary: Effective October 1, 2007 Palm Beach County assumed the rights and obligations of the CVB for Global Spectrum and Aramark for the operation and management of the Convention Center, including food and beverage. The BCC authorized this assumption of duties at the February 27, 2007 BCC workshop. Due to the significant responsibility this action demands a professional position is required to ensure the efficient operation of the Convention Center. During the September 25, 2007 discussion with the BCC regarding the abovementioned contracts staff informed the BCC a position would be requested at a later date to administer the convention center contracts. **The position will be funded from bed tax funds**. <u>Countywide (MC)</u>

Background and Policy Issues:

On February 27, 2007, the BCC directed staff to terminate the CVB's Convention Center Management Agreement and directed staff to provide for the County to assume the Global and Aramark contracts. The position will serve as the County Administrator's designee for the oversight of the Convention Center operations. The position will be supported through bed tax funds.
