

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, TRANSFERRING ALL JURISDICTIONAL CONTROL, MAINTENANCE RESPONSIBILITIES, AND OWNERSHIP OF BARWICK ROAD FROM WEST ATLANTIC AVENUE TO LWDD CANAL L-30, TO THE CITY OF DELRAY BEACH.

WHEREAS, Palm Beach County and the City of Delray Beach have entered into an Interlocal Agreement for Barwick Road from West Atlantic Avenue to LWDD Canal L-30; and,

WHEREAS, the City of Delray Beach city limits encompasses this portion of roadway; and,

**WHEREAS**, the City of Delray Beach has agreed to accept control of, responsibility for, and ownership of Barwick Road from West Atlantic Avenue to LWDD Canal L-30.
