I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Contract with Carrick Contracting Corporation, in the amount of \$1,719,500 for the construction of Fire Station No. 56.

Summary: This contract will provide for the construction of a 5,475 sq.ft. fire station located at 6250 SW 18th street, Boca Raton. The SBE Goal for this project is 15.0 %. Carrick Contracting Corporation will provide 15.6%. The contract time is 365 calendar days to substantial completion. (Capital Improvements Division) District 4 (JM)

Background and Justification: Due to the surrounding area's growth, Fire Station No. 56 is required to provide adequate fire rescue service. Bids were opened on September 26, 2007. The low bidder was deemed non-responsive by the Department. Carrick Contracting Corporation was the low responsive bidder for construction of this facility.


