I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: a Contract with Ric-Man International, Inc. to construct the Wastewater Lift Station Rehabilitation Project in the amount of \$930,974.70.

Summary: On September 26, 2007, five (5) construction bids were received for the Wastewater Lift Station Rehabilitation Project, with Ric-Man International, Inc. being the low bidder in the amount of \$930,974.70. This contract provides for the rehabilitation of four (4) lift stations within the Department's wastewater collection system. The Department staff recommends award of this contract to Ric-Man International, Inc. in the amount of \$930,974.70. The Small Business Enterprise (SBE) participation goal established by the SBE Ordinance (R2002-0064) is 15.00% overall. This contract provides for 15.02% SBE participation.

Background and Justification: The Department owns and operates over 800 wastewater lift stations as part of the wastewater collection system. Many of these lift stations have been in service for over 30 years, reaching the end of their useful life. The Department's Capital Improvements Master Plan calls for the rehabilitation of approximately 10 to 15 lift stations annually. This project will provide for the conversion of four (4) lift stations from dry can (outdated technology) to submersible type (current Department standard). These upgrades will improve increased reliability during hurricane and other emergency events. In addition, as part of the upgrades each lift station will be equipped with a remote telemetry unit which will allow remote monitoring and operation along with a backup battery which will increase the reliability and extend operating time of each lift station during emergencies.


