#### I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve on Preliminary reading and advertise for public hearing on December 18, 2007 at 9:30 a.m.: an Ordinance of the Board of County Commissioners of Palm Beach County, Florida, amending Ordinance No. 95-31 as amended by Ordinance No. 2002-066 and Ordinance No. 05-046, as codified in Sections 2-261 through 2-313 of the Palm Beach County Code, relating to equal employment; providing for additional protected class; providing for definitions; providing for repeal of laws in conflict; providing for severability; providing for inclusion in the Code of Laws and Ordinances; and providing for an effective date.

**Summary:** This ordinance will add gender identity or expression as a protected class to the equal employment ordinance. <u>Countywide</u> (TKF)

**Background and Policy Issues:** The Board of County Commissioners enacted Ordinance 95-31, as amended, which provided for equal opportunities in employment. On October 2, 2007, the Board of County Commissioners directed staff to add gender identity or expression as an additional protected class.

18	WHEREAS, the Board of County Commissioners of Palm Beach County, Florida
19 20	enacted Ordinance 95-31, as amended by Ordinance No. 2002-066 and Ordinance No.
20	2005-046, providing for equal opportunities in employment, and such Ordinance is
22	codified in Sections 2-261 through 2-313 of the Palm Beach County Code; and <b>WHEREAS</b> , the Board of County Commissioners wishes to add an additional
23	protected class.
24	NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF COUNTY
25	COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that Sections 2-261
26	through 2-313 of the Palm Beach County Code be amended:
27	<u>SECTION 1 - PROTECTED CLASSES:</u> Sections 2-261 through 2-313 shall be
28	amended as follows:
29	Each and every reference to the protected classes "race, color, sex, national
30	origin, religion, age, disability, familial status, marital status and sexual orientation" in
31	Sections 2-261, 2-263 (Definition of Discrimination Classification), 2-273(1)(a-b), 2-
32	287(1), 2-288(1)(a-b), 2-312(a)(1-2), 2-312(b), 2-313(c)(1-2), 2-312(d), 2-312(e), 2-
33	312(f), 2-313(1) shall be amended to read "race, color, sex, national origin, religion, age,
34	disability, familial status, marital status, sexual orientation and gender identity or
35	expression."
36	SECTION 2: Section 2-263 of the Palm Beach County Code is hereby
37	amended to include the following definition:
38	Gender Identity or Expression means a gender-related identity, appearance,
39	expression or behavior of an individual, regardless of the individual's assigned sex at
40	birth.

SECTION 3 - REPEAL OF LAWS IN CONFLICT: All local laws and ordinances
applying to the unincorporated area of Palm Beach County, Florida in conflict with any
provisions of this ordinance are hereby repealed.
SECTION 4 - SEVERABILITY: If any section, paragraph, sentence, clause,
phrase, or word of this ordinance is for any reason held by a court to be
unconstitutional, inoperative, or void, such holding shall not affect the remainder of this
ordinance.
SECTION 5 - INCLUSION IN THE CODE OF LAWS AND ORDINANCES:
The provisions of this ordinance shall become and be made a part of the Code of Laws
and Ordinances of Palm Beach County, Florida. The sections of this ordinance may be
renumbered or relettered to accomplish such, and the word "ordinance" may be
changed to "section", "article", or other appropriate word.
SECTION 6 - EFFECTIVE DATE: The provisions of this ordinance shall
become effective upon filing with the Department of State.
