

Summary: In 2000, the Workforce Development Board (now the Workforce Alliance, Inc.) for Palm Beach County identified transportation as a barrier to jobs and education in the Lake Region of Palm Beach County and Hendry County. With the assistance of FDOT, a study was completed and funds were sought for a first rural regional commuter route between Belle Glade and Clewiston. FDOT provided demonstration funds which will be depleted this year. Commuter service was initiated October 2002, under a contract by Palm Tran with a private operator. Service is provided 16 ½ hours a day, 7 days a week, bi-hourly (6:30 a.m. to 10:30 p.m.). Ridership has increased yearly. Trips are expected to exceed 20,000 in CY 2007. Hendry County has committed \$66,343.20 and FDOT has committed \$70,000. The \$70,000 requested from Palm Beach County represents a total of \$206,343.20 for this project. (Attachment 2 and 3) District 6 (D.R.)  Background and Justification: The Lake Region has one of the highest rates of unemployment and lack of automobile ownership in the State of Florida. The LRCR is the only transit route that connects 2 hubs for employment, education, and life sustaining destinations in the Lake Region. Former Governor Bush declared the Heartland Region, which includes the Lake Region, an area of "Critical Economic Concern". The Florida Heartland Rural Economic Development Initiative (FHREDI), a private, not-for-profit economic development organization representing the Heartland Region, is undertaking a mobility study that includes the LRCP. This study is to address a governing structure and financial plan for mobility options in six counties and four communities, including Belle Glade, South Bay and Pahokee. This study includes the service area of the LRCR and is scheduled to be completed in 2008. Both Hendry County and FDOT have committed funding to provide uninterrupted service for the existing LRCR this year with the expectation that the FHREDI study will provide direction for ownership and funding sources for rural trans
