The County has encumbered \$2,829,610 (\$108,832/month) during the previous twenty-six (26) months of the current thirty-six (36) month term contract. The County requests an increase of \$700,000 over the previously authorized amount of \$3,300,000, which includes the Director of Purchasing's ten percent (10%) funding authority to meet increased cabling needs and enterprise network cable projects through contract expiration. This term contract has two (2) twelve (12) month renewal options. No responsive SBE vendor bid within 10% of the low bidder.

The County has encumbered \$2,878,965 (\$82,256/month) during the previous thirty-five (35) months of the current thirty-six (36) month term contract. Based upon historical usage, anticipated additional book needs, and a 3.5% CPI increase as set forth in the existing contract, \$1,123,780 is needed to meet the Library's requirements through the expiration of this twelve (12) month renewal term contract. The Library Department anticipates additional book needs for the newly renovated Clarence E. Anthony Library, the new Hagen Ranch Road and Lawrence Road Branches, and the Wellington Branch. This term contract has one (1) twelve (12) month renewal option remaining. No certified SBE vendor submitted a bid on this project.
