Water Utilities requests an increase of \$950,000 over the previously authorized amount of \$1,900,000 to install 4,618 Neptune radio read meters at the Okeechobee Blvd. Century Village due to the completion of scheduled meter installs for the Village of Royal Palm Beach. This term contract has no renewal options. This is a sole-source provider who is not a certified SBE.

Based upon historical usage (\$261,630) and additional CCTV, audio & television systems requested by ESS and Fire Rescue (\$93,673), \$355,303 is needed to meet the County's requirements through the expiration of this eighteen (18) month renewal term contract. This term contract has no renewal options remaining.

The County requests an increase of \$738,000 over the previously authorized amount of \$1,287,220, which includes the Director of Purchasing's ten percent (10%) funding authority, due to the additional maintenance of Palm Springs and West Palm Beach emergency fleets and volatile market conditions. This term contract has three (3) twelve (12) month renewal options. This purchase is off State of Florida contract #863000061 due to lack of SBE competition for this commodity.
