## I. Executive Brief

Motion and Title: Staff recommends motion to approve: budget transfers from road impact fee reserve accounts to road impact fee appropriation accounts for the following road impact fee funds:

<u>Fund</u> Road Impact Fee Zone 3 Road Impact Fee Zone 4 <u>Amount</u> \$232,760 \$842,011

**Summary:** These budget transfers allow for the appropriation of road impact fee revenues collected in a prior year so that approved road impact fee refunds can be paid.

(Countywide LB)

**Background and Policy Issues:** Article 13, Impact Fees, of the ULDC provides for a refund of impact fees in certain circumstances. Target Stores Boynton Town Center and Peeb Enterprises (Isla Verde) overpaid road impact fees when required road improvements were constructed and cash payments were made for road impact fees. These budget transfers will allow the Impact Fee Office to refund the over payments to the applicants.
