I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Budget Transfer of \$100,000 in the \$25M GO Parks and Cultural Improvements Bond Fund - 2005 from John Prince Golf Learning Center to Park Ridge Golf Course.

Summary: This budget transfer will fund immediate site improvements needed at Park Ridge Golf Course (FKA Lantana Hills Golf Course) caused by weather events and user services. Items to be funded include additional asphalt cart path and drainage improvements. <u>District 6</u> (AH)

Background and Justification: Park Ridge Golf Course is a new 18-hole regulation golf course, developed in a joint effort with the Solid Waste Authority. Since opening the golf course, staff has determined that additional site improvement work is required to improve the playability of the golf course and to eliminate potential golfer safety hazards. As a result of summer rain events, it has been determined that additional areas of asphalt cart path are needed to eliminate erosion, and to ensure that golfers can safely traverse sloping areas of the golf course. In addition, due to the presence of the liner below the surface of the golf course and unanticipated soil conditions in several areas, additional drainage work is required to keep the course playable when there are frequent rains. These improvements will help ensure that the facility can meet the conditions expected by golfers. Staff recommends this budget transfer from the John Prince Golf Learning Center. The uncompleted elements of the John Prince Golf Learning Center project will be completed as future funding is made available.
