I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve:

- A) Agreement with Centre for the Arts at Mizner Park, Inc. for the period February 5, 2008, through June 17, 2008, in an amount not-to-exceed \$150,000 for tent rental costs for the Festival of the Arts Boca event:
- B) A Budget Transfer of \$150,000 in the Transportation Improvement Fund from Reserve for District 4 to the County Transportation Trust Fund;
- C) A Budget Transfer of \$150,000 in the Transportation Trust Fund increasing the annual transfer from the Transportation Improvement Fund and decreasing the annual transfer from the General Fund;
- D) A Budget Transfer of \$150,000 in the General Fund decreasing the annual transfer to the County Transportation Trust Fund and increasing the annual transfer to the Park Improvement Fund; and
- E) A Budget Amendment of \$150,000 in the Park Improvement Fund increasing the annual transfer from the General Fund and increasing the appropriation to the District 4 Recreation Assistance Program (RAP).

Summary: This funding is to help offset the cost of tent rental for the Festival of the Arts Boca event (the Event) to be held from February 29 through March 16, 2008. The Event allows for the reimbursement of eligible project costs incurred by the Centre for the Arts at Mizner Park, Inc. subsequent to February 26, 2008. The budget transfers and budget amendment increase the gas tax support and decrease the ad valorem support of the County Transportation Trust Fund, thereby allowing for the allocation of the available ad valorem support to the District 4 Recreation Assistance Program. At the November 21, 2006 Board meeting, the flexibility of up to \$200,000 in transfers was approved for this purpose. With the approval of this project, the remaining balance available in transfers for District 4 is \$50,000. District 4 (AH)

Background and Justification: Centre for the Arts at Mizner Park, Inc. is a not-for-profit organization whose purpose is to expand cultural resources in the community by creating cooperative programming opportunities in music, dance, theater, film, and fine arts. The Centre for the Arts at Mizner Park offers the Event for seventeen days in February and March to feature the best of music, literature, food and wine for all of South Florida, as well as providing an educational component for the area's children. The Event is held in the Amphitheatre at Mizner Park in a rented clear span tent that allows up to 3,400 people for each event to experience world class talent secure from the weather.

The total cost of the tent rental and associated expenses is anticipated to be approximately \$150,000 for tent rental costs, accessory lighting, air conditioning, flooring and related furnishings, tent installation, tent removal, labor costs, and other miscellaneous expenses related to the Event. This funding from the Recreation Assistance Program –District 4 will offset that amount. The Agreement has been executed on behalf of Centre for the Arts at Mizner Park, Inc., and now needs to be approved by the Board of County Commissioners.

AGREEMENT BETWEEN PALM BEACH COUNTY AND CENTRE FOR THE ARTS AT MIZNER PARK, INC. FOR TENT RENTAL COSTS FOR THE FESTIVAL OF THE ARTS BOCA EVENT

THIS AGREEMENT is made and entered into on ______, by and between Palm Beach County, a political subdivision of the State of Florida, hereinafter referred to as "County" and Centre for the Arts at Mizner Park, Inc., a Florida not-for-profit corporation authorized to do business in the State of Florida, hereinafter referred to as "Centre for the Arts at Mizner Park".

WITNESSETH:

WHEREAS, Centre for the Arts at Mizner Park is a not-for-profit agency whose purpose is to expand cultural resources in the community by creating cooperative programming opportunities in music, dance, theater, film, and fine arts; and

WHEREAS, Centre for the Arts at Mizner Park offers the annual Festival of the Arts Boca event (the "Event"), which features the best of music, literature, food and wine for all of South Florida, as well as providing an educational component for the area's children; and

WHEREAS, The Event is held in the Amphitheater at Mizner park in a rented clear span tent that allows up to 3,400 people for each event to experience world class talent secure from the weather; and

WHEREAS, this year's Event will be held for seventeen (17) days, and is estimated to attract over 20,000 participants; and

WHEREAS, Centre for the Arts at Mizner Park has requested \$150,000 from County to offset costs for tent related expenses for the Event to include tent rental costs, accessory lighting, air conditioning, flooring, and related furnishings, tent installation, tent removal, labor costs, and other miscellaneous expenses relating to the Event; and

WHEREAS, County desires to provide funding for tent rental costs for the Event; and

WHEREAS, funding to assist Centre for the Arts at Mizner Park with tent related expenses for the Event in an amount not-to-exceed \$150,000 is available from the Recreation Assistance Program (RAP) - District 4; and

WHEREAS, cultural and educational events serve a public purpose; and WHEREAS, both parties desire to enter into this Agreement.

NOW THEREFORE, in consideration of the covenants and promises contained herein, the parties hereby agree to the following terms and conditions:

- 1. County agrees to fund an amount not-to-exceed \$150,000 to Centre for the Arts at Mizner Park for tent rental costs, accessory lighting, air conditioning, flooring, and related furnishings, tent installation, tent removal, labor costs, and other miscellaneous expenses relating to the Event, as set forth in Exhibit "A", attached hereto and incorporated herein, hereinafter referred to as the "Project".
- 2. County will use its best efforts to provide said funds to Centre for the Arts at Mizner Park on a reimbursement basis within forty-five (45) days of receipt of the following information:
- a. A written statement that the Project, as specified herein, was carried out in accordance with this Agreement; and
- b. A Contract Payment Request Form and a Contractual Services Purchases Schedule Form attached hereto and made a part hereof as Exhibit "B", which are required for each and every reimbursement requested by Centre for the Arts at Mizner Park. Said information shall list each invoice paid by Centre for the Arts at Mizner Park and shall include the vendor invoice number; invoice date; and the amount paid by Centre for the Arts at Mizner Park along with the number and date of the respective check and/or proof of payment for said payment. Centre for the Arts at Mizner Park shall attach a copy of each vendor invoice paid by Centre for the Arts at Mizner Park along with a copy of the respective check and/or proof of payment, and shall make reference thereof to the applicable item listed on the Contractual Services Purchases Schedule. Further, Centre for the Arts at Mizner Park's Program Administrator and Project Financial Officer shall certify the total funds spent by Centre for the Arts at Mizner Park on the Project and shall also certify that each vendor invoice, as listed on the Contractual Services Purchases Schedule was paid by Centre for the Arts at Mizner Park and approved by Centre for the Arts at Mizner Park as indicated.
- 3. Centre for the Arts at Mizner Park will incur expenses for the Project beginning on February 26, 2008. Those costs incurred by Centre for the Arts at Mizner Park for the Project approved and submitted accordingly by Centre for the Arts at Mizner Park subsequent to February 26, 2008, are eligible for reimbursement by County pursuant to the

terms and conditions hereof.

- 4. RAP funds may be used as a match for other local, state, or federal grant programs, but Centre for the Arts at Mizner Park may not submit reimbursement requests for the same expenses to the County as other fund sources to receive duplicate reimbursement for the same expenses.
- 5. Centre for the Arts at Mizner Park warrants that it is an active not-for-profit corporation, duly chartered and registered with the Florida Department of State, Division of Corporations.
- 6. Centre for the Arts at Mizner Park agrees, warrants, and represents that all of the employees and participants in the Project will be treated equally during employment, and for the provision of services without regard to residency, race, color, religion, disability, sex, age, national origin, ancestry, marital status, or sexual orientation.
- 7. Centre for the Arts at Mizner Park shall be responsible for the operation and maintenance of the Project, including all associated costs.
- 8. The term of this Agreement shall be until June 17, 2008, commencing upon the date of execution by the parties hereto.
- 9. The parties agree that, in the event Centre for the Arts at Mizner Park is in default of its obligations under this Agreement, the County shall provide Centre for the Arts at Mizner Park thirty (30) days written notice to cure the default. In the event Centre for the Arts at Mizner Park fails to cure the default within the thirty (30) day cure period, the County shall have no further obligation to honor reimbursement requests submitted by Centre for the Arts at Mizner Park for the Project deemed to be in default and Centre for the Arts at Mizner Park shall return any County RAP funds already collected by Centre for the Arts at Mizner Park for that Project.
- 10. Notwithstanding any provision of this Agreement to the contrary, this Agreement may be terminated by the County, without cause, upon thirty (30) days prior written notice to the other party. This Agreement may be terminated by the County with cause, upon expiration of the thirty (30) day cure period provided for in Section 9 above.
- 11. Centre for the Arts at Mizner Park shall complete the Project by April 17, 2008, and invoices and checks submitted for reimbursement must be dated within the project time frame of February 26, 2008, through April 17, 2008. Centre for the Arts at

Mizner Park shall provide its final reimbursement request(s), including a project completion statement and reimbursement documentation as indicated in Section 2 above on or before June 17, 2008. Upon written notification to County at least ninety (90) days prior to that date Centre for the Arts at Mizner Park may request an extension beyond this period for the purpose of completing the Project. County shall not unreasonably deny Centre for the Arts at Mizner Park's request for said extension.

- 12. In the event Centre for the Arts at Mizner Park ceases to exist, or ceases or suspends the Project for any reason, any remaining unpaid portion of this Agreement shall be retained by County, and County shall have no further obligation to honor reimbursement requests submitted by Centre for the Arts at Mizner Park. The determination that Centre for the Arts at Mizner Park has ceased or suspended the Project shall be made by County and Centre for the Arts at Mizner Park agrees to be bound by County's determination.
- 13. Centre for the Arts at Mizner Park agrees to abide by, and be governed by, all applicable federal, state, county, and municipal laws, including but not limited to, Palm Beach County's ordinances, as said laws and ordinances exist and are amended from time to time. In entering into this Agreement, Palm Beach County does not waive the requirements of any County or local ordinance or the requirements of obtaining any permits or licenses normally required to conduct business or activity conducted by Centre for the Arts at Mizner Park. Failure to comply may result in County's refusal to honor reimbursement requests for the Project.
- 14. County reserves the right to withhold reimbursement if the Project is not completed as specified in Exhibit "A".
- 15. It is understood and agreed that Centre for the Arts at Mizner Park is merely a recipient of County funding and is an independent contractor and is not an agent, servant or employee of County or its Board of County Commissioners. It is further acknowledged that the County only contributes funding under this Agreement and operates no control over the Project. In the event a claim or lawsuit is brought against County or any of its officers, agents or employees, Centre for the Arts at Mizner Park shall indemnify, save and hold harmless and defend the County, its officers, agents, and/or employees from and against any and all claims, liabilities, losses, judgments, and/or causes of action of any type arising out of or relating to any act or omission of Centre for the Arts at Mizner Park,

its agents, servants and/or employees in the performance of this Agreement. The foregoing indemnification shall survive termination of this Agreement.

In consideration for reimbursement of costs incurred prior to the term of this Agreement, the foregoing indemnification shall apply not only during the term of this Agreement but also for the period prior to the Agreement for which Centre for the Arts at Mizner Park is eligible to receive reimbursement from the County.

16. Centre for the Arts at Mizner Park shall, at its sole expense, agree to maintain in full force and effect at all times during the life of this Agreement, insurance coverages and limits (including endorsements), as described herein. Centre for the Arts at Mizner Park shall agree to provide the County with at least ten (10) day prior notice of any cancellation, non-renewal or material change to the insurance coverages. The requirements contained herein, as well as County's review of acceptance of insurance maintained by Centre for the Arts at Mizner Park are not intended to and shall not in any manner limit or qualify the liabilities and obligations assumed by Centre for the Arts at Mizner Park under the Agreement.

Commercial General Liability. Centre for the Arts at Mizner Park shall maintain Commercial General Liability at a limit of liability not less than \$500,000 Each Occurrence. Coverage shall not contain any endorsement excluding Contractual Liability or Cross Liability unless granted in writing by County's Risk Management Department. Centre for the Arts at Mizner Park shall provide this coverage on a primary basis.

Worker's Compensation Insurance & Employer's Liability. Centre for the Arts at Mizner Park shall maintain Worker's Compensation & Employers Liability in accordance with Florida Statute Chapter 440. Centre for the Arts at Mizner Park shall provide this coverage on a primary basis.

Additional Insured. Centre for the Arts at Mizner Park shall endorse the County as an Additional Insured with a CG 2026 Additional Insured - Designated Person or Organization endorsement, or its equivalent, to the Commercial General Liability. The Additional Insured endorsement shall read "Palm Beach County Board of County Commissioners, a Political Subdivision of the State of Florida, its Officers, Employees and Agents." Centre for the Arts at Mizner Park shall provide the Additional Insured endorsements coverage on a primary basis.

<u>Waiver of Subrogation</u>. Centre for the Arts at Mizner Park hereby waives any and all rights of Subrogation against the County, its officers, employees and agents for each required policy. When required by the insurer, or should a policy condition not permit an insured to enter into a pre-loss agreement to waive subrogation without an endorsement, then Centre for the Arts at Mizner Park shall agree to notify the insurer and request the policy be endorsed with a Waiver of Transfer of Rights of Recovery Against Others, or its equivalent. This Waiver of Subrogation requirement shall not apply to any policy, when a condition to the policy specifically prohibits such an endorsement, or voids coverage should Centre for the Arts at Mizner Park enter into such an agreement on a pre-loss basis.

Certificate(s) of Insurance. Prior to execution of this Agreement by the County, Centre for the Arts at Mizner Park shall deliver to the County a Certificate(s) of coverage evidencing that all types and amounts of insurance coverages required by this Agreement have been obtained and are in full force and effect. Such Certificate(s) of Insurance shall include a minimum ten (10) day endeavor to notify due to cancellation or non-renewal of coverage. Certificate holder's address shall read Palm Beach County, c/o Parks and Recreation Department, 2700 Sixth Avenue South, Lake Worth, FL 33461, Attention: Administrative Support Manager.

Right to Review. County, by and through its Risk Management Department, in cooperation with the contracting/monitoring department, reserves the right to review, modify, reject or accept any required policies of insurance, including limits, coverages, or endorsements, herein from time to time throughout the term of this Agreement. County reserves the right, but not the obligation, to review and reject any insurer providing coverage because of its poor financial condition or failure to operate legally.

- 17. Upon request by County, Centre for the Arts at Mizner Park shall demonstrate financial accountability through the submission of acceptable financial audits performed by an independent auditor.
- 18. Centre for the Arts at Mizner Park shall maintain books, records, documents and other evidence that sufficiently and properly reflect all costs of any nature expended in the performance of this Agreement for a period of not less than five (5) years. Upon advance notice to Centre for the Arts at Mizner Park, County shall have the right to inspect and audit

said books, records, documents and other evidence during normal business hours.

- 19. The County and Centre for the Arts at Mizner Park may pursue any and all actions available under law to enforce this Agreement including, but not limited to, actions arising from the breach of any provision set forth herein.
- 20. This Agreement shall be governed by the laws of the State of Florida and any and all legal action necessary to enforce this Agreement shall be held in Palm Beach County.
- 21. As provided in Section 287.132-133, Florida Statutes, by entering into this Agreement or performing any work in furtherance hereof, Centre for the Arts at Mizner Park certifies that it, its affiliates, suppliers, subcontractors and consultants who will perform hereunder, have not been placed on the convicted vendor list maintained by the State of Florida Department of Management Services within the thirty six (36) months immediately preceding the date hereof. This notice is required by Section 287.133 (3) (a), Florida Statutes.
- 22. This Agreement represents the entire agreement between the parties and supersedes all other negotiations, representations, or agreement, either written or oral, relating to this Agreement. This Agreement may be modified and amended only by written instrument executed by the parties hereto.
- 23. Any notice given pursuant to the terms of this Agreement shall be in writing and hand delivered or sent by U.S. mail. All notices shall be addressed to the following:
