THIS RENEWAL AND AMENDMENT of the Appraiser Agreement dated February 6, 2007, herein after AGREEMENT, by and between the appraisal firm of THE SPIVEY GROUP, INC., hereinafter APPRAISER, and the Board of County Commissioners of Palm Beach County, Florida, hereinafter COUNTY, is entered into and effective as of March 11, 2008.

- 2. The AGREEMENT, dated February 6, 2007 between the APPRAISER and the COUNTY is hereby amended and renewed for one year, expiring on February 8, 2009
