AMENDMENT TO AGREEMENT DATED DECEMBER 20, 2005 WITH BROAD AND CASSEL FOR AIRPORT-RELATED BANKRUPTCY LEGAL SERVICES (PER RFP)

THIS Amendment, made and entered into this day of,
2008, by and between Palm Beach County, a political subdivision of the State of Florida
(the "County"), and Broad and Cassel ("Outside Counsel").
WITNESSETH:

WHEREAS, pursuant to paragraph 4 of the Agreement dated December 20, 2005 ("Agreement") with Broad and Cassel for Airport-Related Bankruptcy Legal Services, the County may, at its sole discretion, exercise its option to renew the Agreement for three (3) additional one year renewal periods;

WHEREAS, the Agreement expired by its own terms on December 20, 2006;

WHEREAS, by virtue of the provisions of paragraph 4 of the Agreement, the County is exercising its option to renew the Agreement for all three successive one year periods, a total of three years, until December 20, 2009;

WHEREAS, the County recognizes that the not-to-exceed contractual cap set forth in paragraph 3 of the Agreement has not been surpassed.

NOW, THEREFORE, in consideration of the mutual covenants, understandings and Agreements set forth herein, the parties agree as follows:

- The above recitals are true and correct and incorporated herein by 1. reference.
- 2. In exchange for adequate consideration, the receipt of which is acknowledged, the Agreement shall be extended for a period of three (3) years from December 20, 2006, or until December 20, 2009, and an additional \$50,000 combined attorney's fees and costs shall be added to the contractual cap set forth in the Agreement.

- 3. This Amendment will also clarify that outside counsel may use subcontractors in situations where it is economically feasible to do so and with the prior approval of the County Attorney's Office.
- 4. As set forth in paragraph 4 of the Agreement, all other terms and conditions contained therein shall remain in full force and effect.
- 5. This Amendment to the Agreement shall be effective upon approval by the Palm Beach County Board of County Commissioners.

IN WITNESS WHEREOF, the parties have duly executed this Amendment to the Agreement with Broad and Cassel for Airport-Related Bankruptcy Legal Services on the day and year reflected in the first line hereof.
