



• WRDA 2000 calls for:

VERVIETA ESTITETA

- Sec. 601(k) Outreach and Assistance -
 - (1) Small Business concerns owned and operated by socially and economically disadvantaged individuals – In executing the Plan, the Secretary {of the Army} shall ensure that small business concerns owned and controlled by socially and economically disadvantaged individuals are provided opportunities to participate under section 15(g) of the Small Business Act
 - (2) Community Outreach and Education
 - (a) In General, the Secretary shall ensure that impacts on socially and economically disadvantaged individuals, including individuals with limited English proficiency, and communities are considered during implementation of the Plan, and that such individuals have opportunities to review and comment on its implementation.
 - (b) Provision of Opportunities the Secretary shall ensure, to the maximum extent practicable, that public outreach and educational opportunities are provided, during implementation of the Plan to the individuals of South Florida, including individuals with limited English proficiency, and in particular for socially and economically disadvantaged communities.

Mandated Activities

- Through CERP Public Outreach Program and Management Plan
 - Ensure South Florida minority communities realize economic gains from CERP.
- Through CERP Environmental and Economic Equity
 Program Management Plan
 - Promote workforce development through partnerships with colleges and skill training programs.
 - Promote workforce training partner with community based organizations to enhance job skills necessary for CERP.




Acceler8 Economic Status to Date

- Over 80% of the workforce hired is from the state of Florida.
- 52% coming directly from the Glades & Clewiston communities.
- More than 80% of the goods and services have been provided from Florida companies
- 20% coming directly from the Glades community.



Local Labor Successes Reservoir Construction

- 310 hourly employees hired, 265 from Florida
 - 124 from the Glades area (South Bay, Pahokee, Belle Glade)
 - 38 from Clewiston
 - 84 from within the District 16 counties
 - 19 from communities outside the 16 counties the District serves, but within Florida



Local Labor Success

- Payroll wages of \$13,541,000 put directly back into Florida residents households incomes
 - \$5,066,000 to residents of the Glades area
 - \$1,740,000 to Clewiston residents
 - \$4,276,000 to Local residents within the Districts counties within Florida
 - \$2,459,000 to Florida residents outside the 16 counties the District serves, but within Florida

Good & Services Expenditures

EAA Reservoir

- \$6,059,550.39 spent in the Glades Area
- \$1,421,323.18 spent in Clewiston
- \$13,548,248.40 spent in the SFWMD's 16 county region
- \$5,284,628.07 spent in Florida's other counties

Workforce Development

- Developed partnerships with local educational institutions to ensure local workforce development and participation
- Developed a curriculum customized to the needs of the contractors
- Workforce Development efforts have been very successful and has directly attributed to the local employment success rate.

SFWMD's Investment in Workforce Development

- District Investment: \$2,146,800.00
- Workforce Development Programs at Palm Beach Community College and Southwest Education Center have produced
 - 114 Construction Craft Graduates
 - 209 Heavy Equipment Operators

South Florida Region

To date, the Everglades Restoration Projects have cost \$193.7 million and created 427 direct jobs within the South Florida Region in 2007.


