Motion and Title: Staff recommends motion to approve: A Release of two Removal Agreements on the north side of State Road 80 between Sunshine Road and Fairgrounds Road.	
Summary: This action approves a Release of two Removal Agreements granted in 1974 and 1986 for the placement of signs on State Road 80 between Sunshine Road and Fairgrounds Road.

Background and Justification: In 1974 and 1986, respectively, the owner of the property located on the north side of State Road 80 between Sunshine Road and Fairgrounds Road entered into a Removal Agreement with Palm Beach County (County) in order to obtain a building permit. This Agreement obligated the property owner to remove, at no expense to the County, certain off site signage from the proposed right-of-way of State Road 80. This signage was removed when the Florida Department of Transportation (FDOT) widened and improved State Road 80. The current owner is in the process of selling the property, but the recorded Removal Agreements have created a cloud on the title of the property. The FDOT has reviewed the request and have stated they have no objections to the property owner's request to have the Removal Agreements released. County staff has also reviewed this request and has no objections.


