### I. EXECUTIVE BRIEF

**Motion and Title: Staff recommends motion to approve:** Supplemental Agreement No. 10 to Project Agreement R2001-1619 in the amount of \$37,349.00 with K-F Group, Inc. (KFG), for professional services.

**Summary:** This Supplemental Agreement will provide the services necessary for the preparation of a wetland and uplands tie-in survey for Jog Road from Roebuck Road to 45<sup>th</sup> Street (Project).

## Districts: 2 and 6 (PK)

**Background and Justification:** On October 2, 2001, the Board of County Commissioners (Board) approved an Agreement (R2001-1619) with KFG to provide professional services required to prepare design plans and construction bid documents for the Project. Palm Beach County (County) now desires KFG to provide additional services for the final wetland and uplands tie-in survey for the Project, as detailed in Exhibit "A" of the attached Supplemental Agreement. In accordance with PPM No. CW-F-050, this Supplemental Agreement must be approved by the Board since the cumulative value of additional services now exceeds \$200,000. The Small Business Enterprise (SBE) goal for the Project is 15%. Due to the nature of the requested additional services, SBE participation was not feasible for this supplement. The fee, as detailed in Exhibit "A" of the attached Supplemental Agreement Agreement, has been negotiated as just and reasonable compensation as follows:

Basic Services (Lump Sum)\$ 36,049.00(Reimbursable Expenses (Not to Exceed)\$ 1,300.00

(Survey, Survey Drawing and Tie-in Stakes) (4-wheel drive ATV)


