I. DAECOTTVE BRIEF

Motion and Title: Staff recommends motion to approve: A County Deed conveying to the Florida Department of Transportation (F.D.O.T.) a certain road right-of-way parcel located at the northwest quadrant of Camino Real and Powerline Road.

Summary: This action conveys to F.D.O.T. a right-of-way parcel for Powerline Road right-of-way that was conveyed to Palm Beach County (County) in 2004.

District: 4 (PK)

Background and Justification: In 2004, Cedar Oil Boca Raton, LLC conveyed to the County, a parcel of land for the right-of-way of Powerline Road at Camino Real. This conveyance was a condition of Petition 2003-082, Resolution 2003-1986, and was recorded in Official Record Book 19335, Page 0622. F.D.O.T. has requested that this parcel be conveyed to them to be used in conjunction with planned improvements along Powerline Road, which is a F.D.O.T. maintained road. The resurfacing, reconstruction and rehabilitation improvements include a new Mast Arm signal system to be installed at the intersection of Powerline Road and Camino Real. The conveyance of this parcel to F.D.O.T. has been reviewed by the Engineering staff and determined to be in the best interest of Palm Beach County.



On December 31, 2004, parcel No. 00-42-47-28-00-000-1011 was dedicated to Palm Beach County, by the owner Cedar Oil Boca Raton, LLC. As you may be aware, the dedication was part of an effort to secure the rights for related improvements being developed by the Department along SR-845 Powerline Road, from the Broward County Line to Glades Road (Milepost 0.045 to 3.045) (FPID 229812-3-52-01). The resurfacing, reconstruction and rehabilitation improvements include a new Mast Arm signal system to be installed at the Camino Real intersection. The Palm Beach County parcel (Book 19335; Page 0622) is located at the northwest quadrant of the Camino Real and Powerline Road intersection. As you may be aware, the dedication was part of an effort to secure the rights for specific signal improvements at the intersection and it was our understanding, after securing the dedication from the property owner, Palm Beach County was going to dedicate the parcel to the Department.
