I. EXECUTIVE BRIEF						
Motion and Title: Staff recommends motion to approve: A one (1) year renewal option to the Lease Agreement with Susan Stechnij and Santiago Boiton for the period of June 1, 2008, through May 30, 2009, in an amount of \$27,900, to provide transitional housing for Community Action clients in the Glades.						
Summary: The Community Services Department Community Action Program currently leases two (2), 2 room suites with Susan Stechnij and Santiago Boiton, at 164 E. 2 nd Street in Pahokee to provide temporary housing for low income individuals. The term of the original Lease Agreement was for one (1) year with one, one (1) year renewal option. The total annual cost of the lease is \$27,900, which consists of \$23,250 in Federal Funds and \$4,650 in County funds. The lease spans two fiscal years. County match is included in the FY 2008 budget and is being requested in the FY 2009 budget. (Community Action Program) <u>District 6</u> (TKF)						
Background and Justification: The one (1) year term of the current Lease Agreement, approved by the Board of May 15, 2007 (R-2007-0753) will expire on May 30, 2008. This one (1) year renewal will enable Palm Beach County to provide temporary housing to clients living in the Glades, at a monthly rate not to exceed \$2,325. The Community Action Program receives funds through the Community Services Block Grant (CSBG) housing component to provide for families in the self-sufficiency program, who meet income criteria.




