I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Consultant Services Authorization (CSA) No. 5 to the contract (R2003-1753) with Pierce Goodwin Alexander & Linville (PGAL) in the amount of \$232,554 for planning, design and construction administration services for the renovations of the Southwest County Regional Library.

Summary: The scope of services provides for architectural and engineering services for building planning, design, permitting and construction administration for renovation of the existing 24,000 sq. ft. building and associated site changes. The construction cost estimate for this project is \$4,680,000. The SBE goal for this project is 15%. PGAL will provide 25.1% SBE participation. (Capital Improvements Division) District 5 (JM)

Background and Justification: PGAL was selected as one of three (3) consultants for the Library Expansion Program in accordance with Board adopted procedures pursuant to the Consultants Competitive Negotiation Act (CCNA), Florida Statute 287.055, to provide professional consultant services associated with design and construction of 17 new, expanded or renovated libraries. The Southwest County Regional Library is one of the libraries identified in the Library Expansion Plan. This project will be located at the existing site west of Boca Raton. The renovations will provide a new drive up automated book drop off, interior and exterior capital maintenance expense items, renovations to interior finishes, and modernization of furniture, fixtures and equipment to better serve the changing needs and trends in library services.



Pierce Goodwin Alexander & Linville (PGAL) is pleased to submit this proposal to provide professional services for the renovation of the Southwest Regional Library located at 20701-95th Avenue South, Boca Raton, Florida.

1. SCOPE OF SERVICES

PGAL will provide services in accordance with current AIA standard practices for projects similar in type and scope, and CID Policy and procedures Manual. Our services shall include the provision of all labor and materials for preparation of the following design and construction documents.

This proposal responds to the initial work description and floor plan provided by Palm Beach County Library to remodel and upgrade the facility to create better usable spaces where needed. The facility will be modified as follows:

BUILDING EXTERIOR

- 1. Create new vehicular drive circulation with stacking for exterior book drop.
- 2. Modify landscaping around exterior book drop to meet CPTED.
- 3. Select new color scheme for building exterior and parking lot fixtures.
- 4. Specify and coordinate re-roofing.

BUILDING INTERIOR

- 1. Lobby
 - Clean grout and existing porcelain ceramic tile floor.
 - Replace all existing light fixtures.
 - Paint all walls, use accent color in archways.
 - Install wall tiles at water cooler.
 - Replace lobby book drop.

2. Restrooms

- Replace countertops.
- Replace ceiling tiles and tracks to moisture resistant products.
- Replace mirrors.
- Replace toilet partitions.
- Replace sink in ADA stall and install per code requirements.
- Clean existing floor tiles and grout.

 - Replace all lighting fixtures.
 - Replace ceiling diffusers.

3. Doors

- Paint frames.
- Refinish all doors.

4. Circulation Desk

- Redesign circulation desk to include 2 standing and 2 sitting stations.
- Redesign drop soffit for new circulation desk.
- Relocate task and accent lighting.
- Remove low wall at queuing.
- Provide design treatment to minimize glare from clearstory windows.

5. Study Room

- Paint all walls.
- Install plastic laminate on walls over counter.
- Install new shelf above study carrel.
- Install new permanent light fixture under shelf.

6. Periodicals

 Propose design changes to ceiling and window details to highlight as a destination focal point and quiet reading area.

7. Young Adult

- Raise ceiling height.

8. Circulation Workroom

- Remove all millwork.
- Refinish walls for modular furniture installation.

9. General

- Modify floor layout per floor plan provided by Palm Beach County Library.
- Paint all walls.
- Replace all carpet and base except in Public Meeting Room.
- Provide OPAC station where needed.
- Modify mechanical ductworks per new floor plan layout.
- Develop new lighting and power requirements per new floor plan layout.
- Modify fire sprinkler plan per new floor plan layout.
- Replace 3 air handler units.
- Replace and upgrade fire and security systems.
- Reupholster and refinish existing furnishing, (Library will provide inventory).
- Provide new artworks.
- New entry to Children's Library.
- Design new interior room and information signage.
- Any modifications necessary in order to obtain a building permit.

PGAL will provide the following as part of Basic Services:

- 1. Meeting with owner to review the program and provide alternative approaches to the design and construction of the project.
- 2. Two different material boards total to be presented for selection comments
- 3. Selection of interior finishes, colors, artwork and graphics, and coordination of purchasing of new furnishings with owner's rep(s).
- 4. Selection of new light fixtures.
- 5. Design custom millworks.
- 6. Selection of fabrics for re-upholstering of existing chairs.
- 7. Meet with County staff and other jurisdictional agencies, obtain and address comments, and modify documents as necessary to obtain all necessary permits.
- 8. Shop drawing review.
- 9. Respond to Contractor or Owner request for information (RFI's).
- 10. Attend bi-weekly job site meetings (maximum of 12 months) to observe the progress of the work and review Contractors application for payment.
- 11. Install automatic book-drop per Library's direction.

2. COMPENSATION

The fixed fee for basic services shall be Two Hundred Seventeen Thousand Three Hundred and Fifty-four Dollars (\$217,354.00) and Non-Reimbursable expenses estimated at Fifteen Thousand Two Hundred Dollars (\$15,200). It shall be allocated to each task of the project as follows:
