I. EXECUTIVE BRIEF

**Motion and Title:** Staff recommends motion to approve: Amendment No. 1 to Contract with Advanced Roofing, Inc. (R2007-1102) to implement the first renewal of an annual roofing contract.

**Summary:** Amendment No. 1 is a renewal to the Annual Contract-Roofing which was awarded to Advanced Roofing, Inc., as one of seven approved roofing contractors. The contractor will continue to perform as an annual roofing contractor for roofing of various facilities. This annual roofing contract is an indefinite-quantity contract and this renewal has a maximum value of \$1,500,000. The renewal term is twelve months or until \$1,500,000 in work orders are issued. Staff is bringing forward the amendment at this time based on pending work which would exceed the value assigned to the contract. All terms of the original contract remain in effect. This is the first of four extensions allowed by the Contract. SBE participation goals for the Roofing contracts ~~are~~ 15%. Advanced's participation for work orders issued to date is 0%. Work orders issued to date for all seven annual contracts include a combined SBE participation of 31.7%. (FD&O Admin) Countywide (JM)

**Background and Justification:** Amendment No. 1 is the first renewal to the Annual Contract-Roofing which was awarded to Advanced Roofing, Inc. on July 10, 2007 as one of seven Annual Roofing Contractors. The contractor will continue to perform as an annual roofing contractor for implementation of remedial roof repairs, roof maintenance, and roof replacements. This annual roofing contract is an indefinite-quantity contract and this renewal has a maximum value of \$1,500,000 among the pool of Annual Roofing Contractors. The renewal term is twelve months or until the renewal limit of \$1,500,000 is reached.

### AMENDMENT #1 TO ANNUAL ROOFING CONTRACT

This agreement amends the contract between Palm Beach County (County) and Advanced Roofing, Inc., (Contractor) authorized pursuant to Palm Beach County Resolution (R-2007-1102).

The original contract provided that Contractor would act as an annual roofing contractor from July 10, 2007 to July 9, 2008 or until the total dollar value of work authorizations issued in the term, among the pool of annual Roofing Contractors, totals One Million five hundred thousand dollars (\$1,500,000), whichever occurred first. That contract also provides that it could be extended for four additional terms. This amendment is the first extension.

The County is extending the contract for a period of twelve (12) months based on pending work which would exceed the value assigned to the contract. Pursuant to the provisions of the existing contract, the parties agree that Contractor will continue to act as an annual roofing contractor until March 31, 2009 or until the total dollar value of work authorizations for the second term totals One Million five hundred thousand dollars (\$1,500,000), whichever comes first. The parties agree that the total dollar value of work authorizations issued pursuant to this amendment shall not exceed One Million five hundred thousand dollars (\$1,500,000).

Except as amended herein, all provisions of the existing contract shall remain in full force and effect.
