# I. EXECUTIVE BRIEF

**Motion and Title: Staff recommends motion to approve:** Change Order No. 7 to the Contract with R.J. Sullivan, Corp. (R2006-0780) for the Water Treatment Plant No. 8 Expansion Project decreasing the contract price by \$44,500.56 and providing a fifty-nine (59) day time extension.

**Summary:** Change Order No. 7 authorizes the Contractor to perform various civil, mechanical, and electrical improvements for this project and to resolve conflicts with the proposed new facilities, and to comply with Building Department permit conditions. It also provides the Contractor with additional time (59 days) to accomplish the additional work. Other revisions are to provide operating staff with additional storage containers for materials and equipment, replacement of the volute of High Service Pump #1 and credits for deleting paving and grading and for the elimination of a hurricane hardening screen wall which is being deleted and replaced with hurricane shutters instead. Total change orders to date, excluding the \$1,712,386.46 sales tax recovery program change order, equal \$884,059.29 (4.75% increase). The Small Business Enterprise (SBE) participation goal established by the SBE Ordinance is 15.0% overall. This change order includes zero overall SBE participation. The contractor's cumulative SBE participation, including this change order, is 26.29% overall. (WUD Project No. 05-146) <u>District 2</u> (JM)

**Background and Justification:** The County has been expanding its utility infrastructure to provide water and wastewater service to the Northern Region including the Beeline Community Development District, Seminole Improvement District and Seacoast Utility Authority. The Water Treatment Plant No. 8 Expansion will provide an additional 10 million gallons per day of potable water to accommodate the utility's expansion. On May 2, 2006, the Board approved the construction contract with R.J. Sullivan Corp. (R2006-0780). This change order will authorize additional electrical work to resolve conflicts, storage containers for the operating staff and replacement of a high service pump volute as well as a credit for eliminating a hurricane hardening screen wall and paving and grading work.



## SCOPE OF WORK

- 7.1 <u>Provide Two Storage Containers For Operating Staff to Store Equipment and Materials</u> (Owner Initiated) – The storage containers are needed by plant operators for the storage of spare parts, materials and equipment associated with the expanded water treatment plant.
- 7.2 <u>Delete Screen Wall on South Side of Sodium Hypochlorite Generation Building and Install Hurricane</u> <u>Shutters Over Existing Louvers in its Place (Owner Initiated).</u> A credit is being taken to install shutters instead of a screen wall which would have been in conflict with existing plant process piping.
   7.3 <u>Delete Site Work Described in Schedule of Values Line Items 19E, 19H, 19J 19K, 19N, 19</u>
- (Owner Initiated) This work is being deleted and enhanced landscaping and site improvements will be performed by WUD landscape architect under an existing WUD annual contract.
- 7.4 <u>F&I Electrical Conduit & Wiring to Accommodate Revised equipment Layout for Lime Silo Building</u> (Errors/Ommissions in Design) There was not sufficient space provided in the Lime Silo building to accommodate the lime slakers, equipment and electrical panels specified. Some of the panels and equipment had to be relocated outside the building.
- 7.5 <u>F&I 2-Inch Backflow Preventer on Potable Water Main to Lime Silo Building (Errors/Ommissions in Design).</u> A backflow preventer required by the Building Code was not shown on the drawings.
- 7.6 <u>F&I Additional Electrical Conduit and Wiring to Accommodate Revised Location of Carbon Dioxide</u> <u>Feed Panel (Owner Initiated).</u> During the shop drawing phase of the project, the manufacturer of the carbon dioxide feed system recommended relocating the carbon dioxide injection point for better mixing and performance of the system.
- 7.7 <u>Furnish Two Six Inch Backflow Preventers for the Potable Water main into Softener #3</u> (Errors/Omissions in Design) Backflow preventers required by the Building Code were not shown on the drawings.
- 7.8 <u>F&I Electrical Conduit & Wiring (Errors/Omissions in Design) No conduit or wiring for the specified control valves was shown on the drawings.</u>
- 7.9 to F&I Electrical Revisions to Filter Building Air Conditioning Units (Errors/Omissions in Design) During
- 7.11 shop drawing review the consultant directed the contractor to wire the air conditioning units to a different panel than that which was shown on the drawings.
- 7.12 <u>Provide Credit for Electrical Conduit & Wire Allowance Specified in Contract Documents (Owner Initiated)</u>. The contract documents specify that the contractor include an allowance in the bid to account for unforeseen electrical conduit and wiring work.
- 7.13 <u>F&I pipe supports for lime slurry line to Softener #3 (Errors/Omissions in Design)</u>. No pipe supports were shown on the drawings to support this elevated piping.
- 7.14 <u>Furnish new volute for High Service Pump #1 (Owner Initiated).</u> During change out of H.S. Pump #1 impeller it was discovered the pump volute was deteriorated and needs to be replaced.


