I. EXECUTIVE BRIEF
Motion and Title: Staff recommends motion to adopt: Resolution abandoning those certain unimproved portions of thre (3) thirty (30) foot wide unimproved roads within Tracts G, H I, and J, the plat of Osceola Groves, as recorded in Plat Boo 20, Page 30, Public Records of Palm Beach County, Florida.
Summary: This petition site is located approximately 2 mile south of State Road 76 and 1 mile east of US 441. As condition of approval for a Type IIIA sand/rock minin operation, the development is required to abandon thes unimproved road rights-of-way.
District: 1 (PK)
Background and Policy Issues: The owner, Five Smooth Stones Inc., wants to develop a Type IIIA rock mining operation. The development was approved by the Board of County Commissioners of November 18, 2004 (Petition Number 2003-100). As part of their condition of approval, these unimproved road rights-of-way must be abandoned. These unimproved roads are not depended upon for access.
Utility service providers have no objection to the vacation.
Privilege Fee Statement:
The petition is subject to a privilege fee of \$14,968.01. The calculations are as follows:



RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, ABANDONING THOSE CERTAIN UNIMPROVED PORTIONS OF THREE (3) THIRTY (30) FOOT WIDE UNIMPROVED ROADS WITHIN TRACTS G, H, I, AND J, THE PLAT OF OSCEOLA GROVES, AS RECORDED IN PLAT BOOK 20, PAGE 30, PUBLIC RECORDS OF PALM BEACH COUNTY, FLORIDA.

WHEREAS, the Board of County Commissioners of Palm Beach County, Florida, pursuant to authority in Section 336.09, Florida Statutes, and Ordinance No. 86-18 known as the Palm Beach County Right-of-Way Abandonment and Plat Vacation Ordinance, as amended, and the petition of Five Smooth Stones, Inc., called a public hearing to be held in the County Commissioners' Chambers, at the Governmental Office Complex, West Palm Beach, Florida, on May 20, 2008, to consider and determine whether or not Palm Beach County would vacate, abandon, discontinue and close, renounce and disclaim any right or interest of the County to three unimproved rights-of-way within the plat of Osceola Groves; and

WHEREAS, in accordance with Ordinance No. 86-18, as amended, notice of the holding of such meeting was duly published in the Palm Beach Post on May 1, 2008; and

WHEREAS, this Board, did hold said hearing as advertised and determined that such action will not materially interfere with the County Road System and will not deprive any person of a reasonable means of ingress and egress from at least one County, State or Federal highway.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

1. The foregoing recitals are hereby reaffirmed and ratified.

- 2. These rights-of-way are hereby abandoned and closed as rights-of-way and this Board does hereby renounce and disclaim any right or interest of Palm Beach County and the Public in and to these rights-of-way, more fully described in the legal description and sketch attached hereto and made a part hereof.
- 3. Notice of the adoption of this Resolution shall be published once in the Palm Beach Post within thirty (30) days of the date of adoption of this Resolution in accordance with Section 336.10, Florida Statutes and Ordinance No. 86-18.
