SECOND AMENDMENT TO ACCESS AGREEMENT FOR REMEDIAL WORK BETWEEN PALM BEACH COUNTY AND REMEDIATION AND LIABILITY MANAGEMENT COMPANY, INC.

This Second Amendment to Access Agreement for Reme	edial Work (this "Second
Amendment") is made and entered into	, 20

"COUNTY"), and Remediation and Liability Management Comp	oany, Inc., ("REALM ["]) a
Michigan corporation authorized to do business in the State of F	• • • • •

WITNESSETH:

WHEREAS, COUNTY, by and through its Department of Airports (the "Department"), owns and operates the Palm Beach International Airport (the "Airport") located in Palm Beach County, Florida; and

WHEREAS, the parties have entered into that certain Access Agreement for Remedial Work between COUNTY and REALM dated June 20, 2006 (R-2006-1109), as amended (the "Access Agreement"); and

WHEREAS, pursuant to the Access Agreement, REALM is conducting certain remediation activities on a portion of the Airport; and

WHEREAS, REALM has requested additional time to complete the remediation activities; and

WHEREAS, the parties hereto desire to amend the Access Agreement in accordance with the terms and conditions set forth herein.

- **NOW, THEREFORE**, in consideration of the premises and of the mutual covenants herein contained, and for such other good and valuable consideration, the receipt of which the parties hereby expressly acknowledge, the parties hereto covenant and agree to the following terms and conditions:
- 1. The recitals set forth above are true and correct and form a part of this Second Amendment.
- 2. The parties hereby agree that Section 2 of the Access Agreement is hereby deleted in its entirety and replaced with the following:
 - 2. <u>Term/Effective Date.</u> This Agreement shall become effective when signed by the parties hereto and approved by the Board of County Commissioners ("Effective Date"). The term of this Agreement shall commence on the Effective Date and shall expire on June 20, 2010.
- 3. Except as specifically amended herein, all of the terms and conditions of the Access Agreement shall remain unmodified and in full force and effect and are hereby ratified and confirmed by the parties hereto.
- 4. This Second Amendment shall become effective upon execution by the parties hereto.
