I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Release of Utility Easement on land owned by GKK – Hagen Ltd.

Summary: This document will release the County's interest in a utility easement (Easement) recorded in the Official Records of Palm Beach County in Book 11010, Page 1824 and in Book 15854, Page 0488 on land owned by the William A. Mazzoni Revocable Trust and subsequently sold to GKK – Hagen Ltd. (PCN 00-42-43-27-05-049-1050). The Water Utilities Department has determined that this Easement is no longer needed, and therefore recommends the release. <u>District 5</u> (JMB)

Background and justification: On February 6, 1998, and again on August 28, 2003 the property owner granted a utility easement to the County on the property designated as PCN 00-42-43-27-05-049-1050. Upon subsequent sale and development of the property, it was determined that the County's pipelines would need to be relocated outside of this easement. The property owner will provide suitable easements for his development of the property and is now requesting release of the easement that the County will no longer need.


