### I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Supplemental Agreement No. 8 to Project No. 2003507 under contract R2004-0192 in the amount of \$49,325.18 with Miller-Legg and Associates, Inc., for professional services.

**SUMMARY:** This Supplemental Agreement will provide the services necessary for the preparation of plan revisions to split Project No. 2003507 into two separate projects for the widening of Congress Avenue from south of Lantana Road to south of Melaleuca Lane.

**Background and Justification:** On February 3, 2004, the Board of County Commissioners (Board) approved an Agreement R2004-0192 with Miller-Legg and Associates, Inc. (MLA) to provide professional services required to prepare design plans and construction bid documents for Congress Avenue from south of Lantana Road to south of Melaleuca Lane (Project). Palm Beach County now desires MLA to prepare plan revisions to split the Project into two separate projects, and to provide other miscellaneous services, as detailed in Exhibit "A" of the attached Supplemental Agreement. In accordance with PPM No. CW-F-050, this Supplemental Agreement must be approved by the Board since the cumulative value of additional services now exceeds \$200,000. The Small Business Enterprise (SBE) goal for the Project is 15%. Due to the nature of the requested additional services, the SBE participation committed for this supplement by MLA is 12.18%. The fee, as detailed in Exhibit "A" of the attached Supplemental Agreement and the reasonable compensation as follows:




