**I. EXECUTIVE BRIEF**

**Motion and Title:** **Staff recommends motion to adopt:** Resolution of the Board of County Commissioners of Palm Beach County, Florida, changing the street name of Fairgrounds Road to Process Drive, located in Section 31, Township 43, Range 42, West Palm Beach.

**Summary:** Planning, Zoning & Building Department (PZ&B), along with Facilities, Development & Operations (FD&O) requests a street name change for the east/west segment of Fairgrounds Road, to eliminate and/or reduce confusion with another street in the unincorporated area with the same name. This duplication could result in a delay of emergency services to the area. Upon receiving a copy of the approved resolution, PZ&B Staff will implement the name change by notifying appropriate parties and agencies. (District 6) RB




**Background and Policy Issues:** Fairgrounds Road is located in unincorporated Palm Beach County and travels in an east/west direction from N. State Road 7 to Sansbury's Way. Palm Beach County Facilities, Development & Operations notified the Addressing Department that there are two streets within the unincorporated area that have the exact same name. The subject street name duplicates an existing street, located in the same area, connected to said street and running perpendicular to it. There are fifteen (15) parcels owned by a total of nine (9) property owners that will be affected by this change. All nine (9) property owners have been notified by mail of this proposal.

This request is consistent with adopted County policies and procedures for street name changes set forth in Resolution 74-183. In the case of duplication, no fee is required.

**RESOLUTION NO. R-08-**

**RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, CHANGING THE STREET NAME OF FAIRGROUNDS ROAD TO PROCESS DRIVE, LOCATED IN SECTION 31, TOWNSHIP 43, RANGE 42, WEST PALM BEACH**

**WHEREAS**, the Board of County Commissioners of Palm Beach County, Florida, is authorized under Section 336.05, Florida Statutes, to name and rename streets and roads lying outside the boundaries of any incorporated municipality; and

**WHEREAS**, the Board of County Commissioners of Palm Beach County, Florida, has, by Resolution No. R-74-183, as amended and supplemented by Resolution No. R-91-1145, adopted a system of street naming and numbering for Palm Beach County; and

**WHEREAS**, the Administration Division of the Palm Beach County Planning, Zoning and Building Department has reviewed the situation and finds that confusion exists, caused by two streets having the same name; and

**WHEREAS**, the proposed name of Process Drive will eliminate the confusion, and does not duplicate any other street name in the unincorporated area of Palm Beach County; and

**WHEREAS**, the road which will be renamed has fifteen (15) parcels of which all property owners will be notified of the change; and

**WHEREAS**, all but one property owner has signed a petition agreeing to this change; and

**WHEREAS**, the Planning, Zoning and Building Department has reviewed the proposed street name change and finds this request consistent with adopted County policy and procedures for street name changes and that the change meets all specified conditions.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMIS-**

**SIONERS OF PALM BEACH COUNTY, FLORIDA, that:**

1. The street name of Fairgrounds Road is a duplication and could potentially lead to a delay in response time. Fairgrounds Road, located in West Palm Beach, which travels in an east/west direction from N. State Road 7 to Sansbury's Way is hereby changed and the street shall be known as Process Drive. This road is delineated on the accompanying map and the resolution shall be recorded in the Public Records of Palm Beach County.

2. All appropriate agencies shall be notified by the Palm Beach County Planning, Zoning and Building Department of such official change.

3. The Clerk & Comptroller shall indicate the street name changes on the affected plat and/or plats.



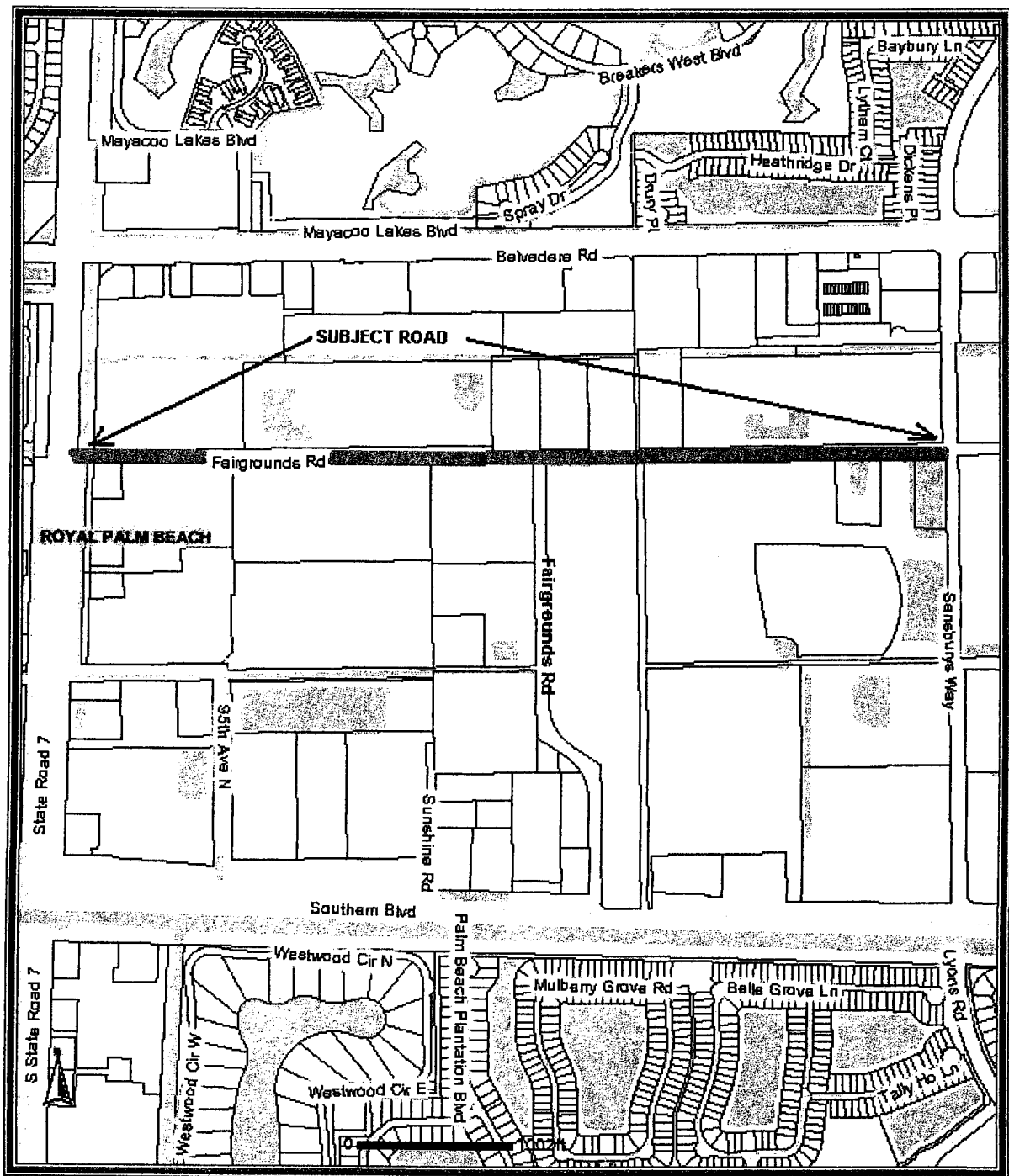

RE: Resolution for Street Name Change –  
Fairgrounds Road ("Processing Drive")

In accordance with the standards and requirements for naming streets as set forth in Resolution No. 74-183 and amended in Resolution No. 91-1145, street name changes shall be permitted in response to a Board of County Commissioners' directive, to eliminate duplication or confusion in street names, or to reduce confusion in addressing. To this end, FD&O has proposed changing the name of the east-west segment of Fairgrounds Road (commonly referenced as Fairgrounds Road North) to Processing Drive.

Fairgrounds Road is currently composed of an east-west segment from Sansburys Way to State Road 7/US 441, and an intersecting north-south segment that extends south to Southern Boulevard. To rectify the current state of confusion that is borne by the duplicate use of Fairgrounds Road for intersecting streets, and as a proactive measure to facilitate easy way-finding to existing and future correctional facilities (but more importantly the proposed countywide video visitation center and first appearance court); FD&O is proposing the name Processing Drive for the east-west segment of Fairgrounds Road.

The east-west segment of Fairgrounds Road is bordered by 15 parcels that are owned by eight (8) parties other than the County. All eight (8) parties have been given notice of this initiative; all *public* property owners (South Florida Fair, SFWMD, and SWA) returned consent; and four (4) of five (5) *private* property owners (including Wal-Mart Stores, Amoco Oil Co., and several local corporations) returned consent. The only party withholding consent sited concern for reduction in property value. The lack of consent from this property owner does not preclude the Board from changing the street name as a directive or to eliminate the prevailing duplication and/or confusion in street names.

Please contact me no later than Friday, May 9, 2008 with any comments or concerns regarding this initiative. Otherwise, FD&O staff will coordinate with the Addressing Section of PZ&B to place a Resolution for this street name change on a forthcoming BCC agenda.




Dear Property Owner/Representative:

This letter follows a series of recent correspondence regarding a name change for Fairgrounds Road (commonly referenced as Fairgrounds Road North). The purpose of this initiative is to eliminate duplication of the name Fairgrounds Road for the separate east-west and north-south segments of Fairgrounds Road. The goal of this initiative is to avoid confusion, ease way-finding, and address the potential for delayed response time in the event of an emergency.

All previous correspondence has reflected the name "Processing Drive" as the chosen alternative to Fairgrounds Road. Upon further review by Palm Beach County staff, the name Process Drive (in lieu of Processing Drive) will be presented to the Board of County Commissioners for final action. The name Process Drive retains the thematic relationship to the collection of public and private uses upon the adjacent properties and was ultimately chosen (in lieu of Processing Drive) for reasons of brevity and clarity.
