**AMENDMENT TO THE ANNUAL MICROSURFACING
CONTRACT NO. 2007055 DATED MAY 15, 2007 BY AND
BETWEEN FLORIDA HIGHWAY PRODUCTS, INC., AND
PALM BEACH COUNTY**

THIS AMENDMENT to the Annual Microsurfacing Contract dated May 15, 2007, (R-2007-0734), hereinafter "CONTRACT" by and between Florida Highway Products, Inc., hereinafter "CONTRACTOR" and the BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, a political subdivision of the State of Florida, hereinafter, "COUNTY".

W I T N E S S E T H

WHEREAS, on May 15, 2007, the CONTRACTOR and COUNTY entered into an Annual Microsurfacing Contract for overlaying existing pavement on various roadways throughout Palm Beach County; and

WHEREAS, Section 33 of the contract provides that the contract may be extended, at the COUNTY'S option for a defined period of time, not to exceed thirty-six months total contract time, upon approval of the Board of County Commissioners; and

WHEREAS, by this amendment, the CONTRACTOR and the COUNTY mutually agree to extend the CONTRACT retroactively from May 15, 2008 to September 30, 2009, with all original terms, conditions and unit prices adhered to; and

NOW, THEREFORE, in consideration of the mutual covenants, promises, and agreements herein contained, the parties agree as follows:

1. The above recitations are true and correct and incorporated herein. The CONTRACT, dated May 15, 2007, between the CONTRACTOR and the COUNTY is hereby amended to extend the expiration date of the CONTRACT retroactively from May 15, 2008 to September 30, 2009.
2. It is the intent of the parties hereto that this Agreement shall not become binding until the date executed by the COUNTY.
3. All other provisions of the Annual Microsurfacing Contract dated May 15, 2007, shall remain in full force and effect.
