Motion and Title: Staff recommends motion to approve: A County Deed transferring certain rights-of-way to the Village of Palm Springs (Village).							
SUMMARY: A recent review by staff and the Village has disclosed that certain rights-of-way, as shown in Exhibit "A" of the County Deed, being Lark Road, a portion of Davis Road, and a portion of 2 nd Avenue North, are wholly within the Village limits. The Village has sent a request for a County Deed for these roads.

These roads are not maintained by Palm Beach County (County), but the County owns rights-of-way along these roads, acquired at no cost, with one exception, and by plats. There is also a drainage easement along Davis Road that serves only that portion of Davis Road that will also be transferred to the Village.							
The Village is maintaining these roads, and in order to remove any possible complication regarding their ownership, title, and rights, they have requested a County Deed. Staff has reviewed the requested portions and has no objections to the transfer.


