I. <u>EXECUTIVE BRIEF</u>

Motion and Title: Staff recommends motion to receive and file: Grant Adjustment Notice amending the Florida Department of Law Enforcement Florida Consortium "2007 Paul Coverdell National Forensic Sciences Improvement Grant" to extend the ending grant period from September 30, 2008 thru March 31, 2009.

Summary: The Board of County Commissioners (BOCC) accepted this grant for \$43,701 on March 11, 2008; the original period for this grant was October 1, 2007 thru September 30, 2008 (R-2008-0452). This agenda item will extend the grant period from September 30, 2008 thru March 31, 2009. The National Institute of Justice (NIJ) awarded these funds to the Florida Department of Law Enforcement (FDLE) for the "2007 Paul Coverdell National Forensic Sciences Improvement Grant". On January 2, 2008, the Palm Beach County Sheriff's Office (PBSO) was awarded funds to improve the quality of forensic services. The PBSO's Technical Services Division will use the funds provided for training. There is no match requirement associated with this award.
